No. S.R.O. 450-L/80.—The following draft of certain further amendments in the Income-tax Rules which the National Board of Revenue proposes to make in exercise of the powers conferred by section 59 of the Income-tax Act, 1922 (XI of 1922), read with sub-section (1) of section 21AA of the said Act, is hereby published as required by sub-section (4) of the said section 59 for the information of all persons likely to be affected thereby and notice is hereby given that said draft will be taken into consideration on or after a period of thirty days from the date of publication of this Notification. Any objection or suggestion which may be received from any person in respect of the said draft before the expiry of the aforesaid period will be considered by the National Board of Revenue.

Draft Amendments

In the aforesaid Rules, after rule 52, the following new rule 53 shall be added, namely:—

Explanation.—In this rule, the words "nationalised bank" means a new bank within the meaning of Article 2 of the Bangladesh Banks Nationalisation Order, 1972.".
