Dhaka, the 16th October 1984

No. S.R.O. 451-L/84/MVRT/3M-4/84.—The following draft of certain further amendments to the Motor Vehicles Rules, 1940, which it is proposed to make in exercise of the powers conferred by section 136 of the Motor Vehicles Ordinance, 1983 (LV of 1983), is hereby published, as required by subsection (1) of section 173 of the said Ordinance, for the information of all persons likely to be affected thereby and notice is hereby given that the draft will be taken into consideration on or after the 15th November, 1984.

2. Any objection or suggestion which may be received from any person with respect to the said draft before the date specified will be considered by the Government:

Draft Amendment

In the aforesaid Rules .-

- (1) for rule 216, the following shall be substituted, namely:-
- "216. Requirements of policies and limits of liability.—(1) A policy of insurance in respect of a motor vehicle shall not be deemed to comply with the requirements of Chapter IX of the Motor Vehicles Ordinance, 1983 (LV of 1983) unless it covers—
 - (a) any liability arising under the provisions of the Workmen's Compensation Act, 1923 (VIII of 1923), in respect of the death of, or bodily injury to any paid employee engaged in driving or otherwise in attendance on, or being carried in that motor vehicle being limited to six such employees excluding the driver;

- (b) any liability which may be incurred by the insured-
 - (i) in case of death of the victim of motor accident, a sum of twenty thousand taka;
 - (ii) in the case of injuries to the victim causing permanent disablement or loss of any limbs, ten thousand taka;
 - (iii) in the case of any other injury to the victim, five thousand taka; and
 - (iv) in the case of any damage to any property of a third party in any one accident, a sum not exceeding fifty thousand taka.
- (2) The victim of a motor accident or if he is dead, his heir shall be entitled to get as compensation from the insurer or owner of the motor vehicle involved in the accident—
 - (a) in the case of death of the victim, a sum of twenty thousand taka;
 - (b) in the case of injuries to victim causing permanent disablement or loss of any limbs, ten thousand taka;
 - (c) in the case of any other injury for which medical attention was required, five thousand taka; and
 - (d) in the case of any damage to his property, a sum not exceeding fifty thousand taka.
- (3) A demand for compensation shall, at the first instance, be made to the insurer or, in the absence of valid insurance policy, to the owner of the motor vehicle involved in the accident, as the case may be.
- (4) If the insurer or the owner of the motor vehicle concerned fails to pay the compensation within thirty days of the demand made to the insurer or the owner, as the case may be, under Section 111 (2) of the aforesaid Ordinance, the procedure laid down in Chapter IX shall be followed."
