In the aforesaid order,-

- (i) in Annex I, in sub-head A, after serial number 809, the following shall be added, namely:—
  - "810. Chlorpromazine Hydrochloride
    - 811. Tolmetin Sodium Dihydrate
    - 812. Econazole Nitrate"; and
- (ii) in Annex II, in sub-head A, after serial number 632, the following shall be added, namely:—
  - "633. Tefose
    - 634. Labrafil".

#### NOTIFICATION

## Dhaka, the 8th December, 1983

No. S.R.O. 475-L/83/MVRT/IA-I/82.—The following draft of certain further amendments to the Motor Vehicles Rules, 1940, which it is proposed to make, in exercise of the powers conferred by sections 21, 41 and 68 of the Motor Vehicles Act, 1939 (IV of 1939), is hereby published as required by sub-section (1) of section 133 of the said Act for the information of all persons likely to be affected thereby, and notice is hereby given that the draft will be taken into consideration on or after 20th December 1983.

Any objection or suggestion which may be received from any person with respect to the said draft before the date specified will be considered by the Government:

### **Draft Amendments**

In the aforesaid Rules,-

- (1) in rule 3, in clause (a), for the words "the Dacca Metropolitan Area" the words "a Metropolitan Area" shall be substituted;
- (2) in rule 7,-
  - (a) in sub-rule (b), for the words "the Dacca Metropolitan Area" the words "a Metropolitan Area" shall be substituted; and
  - (b) in sub-rule (c), in clause (1), in sub-clause (i), for the words "the Dacca Metropolitan Area" the words "a Metropolitan Area" shall be substituted;
- (3) in rule 29, in clause (i), for the words "the Dacca Metropolitan Area" the words "a Metropolitan Area" shall be substituted;
- (4) in rule 30, in sub-rule (b), in clause (i), for the words "the Dacca Metropolitan Area" the words "a Metropolitan Area" shall be substituted;
- (5) in rule 35A, in sub-rule (8), for clause (ii) the following shall be substituted, namely:—
  - "(ii) Deputy Police Commissioner (Traffic), Chittagong Metropolitan Police,";
- (6) in rule 53,-
  - (a) in sub-rule (a), for the word "twenty" the words "twenty three" shall be substituted;
  - (b) in sub-rule (b), for the words "the Dacca Metropolitan Area" the words "a Metropolitan Area" shall be substituted; and

(c) after sub-rule (bbb), the following new sub-rule shall be inserted, namely:—

"(bbbb) for the region of the Chittagong Metropolitan Area, the Regional Transport Authority shall consist of—

- (i) the Police Commissioner, who shall be ex-officio Chairman;
  - (ii) the Executive Engineer (Roads and Highways) Chittagong Road Division;
- (iii) One Commissioner of the Chittagong Municipal Corporation to be selected by the Government or, until the Corporation is constituted, the Administrator or the Deputy Administrator as may be nominated by the Government or, in the case of supersession of the said Corporation, such persons or authority as may be nominated by the Government;
- (iv) not more than three other members appointed by the Government; and
- (v) the Deputy Police Commissioner (Traffic), who shall be ex-officio Secretary."; and
- (7) in the Third Schedule,-
  - (a) against item No. 5 in the first column, in the second column, for the word "Ditto" the words "Existing boundary of the district except the areas within the boundary of the Chittagong Metropolitan Area" shall be substituted;
  - (b) against item No. 6 in the first column, in the second column, for the word "Ditto" the words "Existing boundary of the district" shall be substituted; and
  - (c) after item No. 20 in the first column and the entries relating thereto in the second and third columns, the following shall be added, namely:—
- "21. Jamalpur Existing boundary Office of the Deputy of the district Commissioner
  - Bandarban Ditto Ditto.
- 23. Chittagong Metropolitan Area.

  The areas within the Office of the Deputy Police boundary of the Commissioner (Traffic)."
