No. S.R.O. 572-L/84/LMVIII/5(2)/84.—Whereas the Government is of the opinion that all classes of employment under the Bangladesh Gas Fields Co. Ltd., the Bakhrabad Gas Systems Ltd., the Sylhet Gas Fields Co. Ltd., and the Jalalabad Gas Transmission and Distribution System are essential for maintaining services necessary to the life of the community;

Now, therefore, in exercise of the powers conferred by sub-section (1) of section 3 of the Essential Services (Second) Ordinance, 1958 (E.P. Ord. XLI of 1958), the Government is pleased to declare all classes of employment under the said Bangladesh Gas Fields Co. Ltd., the Bakhrabad Gas System Ltd., the Sylhet Gas Fields Co. Ltd., and the Jalalabad Gas Transmission and Distribution System to be classes of employment to which the above said Ordinance applies.

NOTIFICATION

No. S.R.O. 573-L/84/MF/IRD-III/NS-Admn-33/82/658.—In pursuance of the Proclamation of the 24th March, 1982 and in exercise of all powers enabling him in that behalf, the President after consultation with the Bangladesh Public Service Commission, is pleased to make the following rules, namely:—

THE NON-GAZETTED STAFF (DEPARTMENT OF NATIONAL SAVINGS) RECRUITMENT RULES, 1984.

- 1. Short title.—These rules may be called The Non-Gazetted Staff (Department of National Savings) Recruitment Rules, 1984.
- 2. Definition.—In these rules, unless there is anything repugnant in the subject or context,—
 - (a) "appointing authority" means the Government and includes in relation to any specified post or class of such posts, any officer authorised by the Government to make appointment to such post or class of posts;
 - (b) "Commission" means Bangladesh Public Service Commission;
 - (c) "recognised University or Board" means a University or Board established by or under any law for the time being in force and includes any other University or Board declared by the Government, after consultation with the Commission, to be a recognised University or Board for the purpose of these rules;
 - (d) "requisite qualification" in relation to a specified post, means the qualification laid down in column 5 of the Schedule in relation to that post;
 - (e) "Schedule" means the Schedule annexed to these rules; and
 - (f) "specified post" means a post specified in the Schedule.
- 3. Procedure for recruitment.—(1) Subject to the provisions to the Schedule and instructions relating to reservation and quota appointment to a specified post shall be made:—
 - (a) by direct recruitment; and
 - (b) by promotion,
- (2) No person shall be appointed to a specified post unless he has the requisite qualification and, in case of direct recruitment, he is also within the age limit specified in the Schedule for that post.

- Appointment by direct recruitment.—(1) No appointment to a specified
 post by direct recruitment shall be made except upon the recommendation of
 the Commission.
- (2) No person shall be eligible for appointment to a specified post by direct recruitment if he—
 - (a) is not a citizen of Bangladesh or a permanent resident of or domiciled in Bangladesh provided that this clause shall not apply in the case of a person who is already in service in the Republic; and
 - (b) is married to, or has entered into a promise of marriage with, a person who is not a citizen of Bangladesh.
- (3) No appointment to a specified post by direct recruitment shall be made until--
 - (a) the person selected for appointment is certified by a Medical Officer appointed by the Director-General of Health Services in this behalf to be medically fit for such appointment and that he does not suffer from any such organic defect as is likely to interfere with the discharge of the duties of the specified post;
 - (b) the antecedents of the person so selected have been verified through appropriate agencies and found to be such as do not render him unfit for appointment in the service of the Republic.
- 5. Appointment by promotion.—(1) Appointment by promotion to a specified post shall be made by the appointing authority on the recommendation of the Departmental Promotion Committee constituted for the purpose by the Government.
- (2) A person shall not be eligible for appointment by promotion to a specified post, if he has unsatisfactory records of service.
- 6. Probation.—(1) Persons selected for appointment to a specified post against a substantive vacancy shall be appointed on probation,—
 - (a) in the case of direct recruitment, for a period of two years from the date of substantive appointment; and
 - (b) in the case of promotion, for a period of one year from the date of such appointment:

Provided that the appointing authority may, for reasons to be recorded in writing extend the period of probation in the case of any person by a period or periods so that the extended period does not exceed two years in the aggregate.

- (2) Where, during the period of probation of a probationer, the appointing authority is of opinion that his conduct and work is unsatisfactory or that he is not likely to become efficient, it may, before the expiry of that period—
 - (a) in case of direct recruitment, terminate his service; and
 - (b) in the case of promotion, revert him to the post from which he was promoted.

- (3) After the completion of the period of probation including the extended period, if any, the appointing authority—
 - (a) if it is satisfied that the conduct and work of the probationer during his period of probation has been satisfactory, shall, subject to provision of sub-rule (4), confirm him; and
 - (b) if it is of opinion that the conduct and work of the probationer during the period was not satisfactory, may,—
 - (i) in the case of direct recruitment, terminate his service; and
 - (ii) in the case of promotion, revert him to the post from which he was promoted.
- (4) A probationer shall not be confirmed in a specified post until he has passed such examination and undergone such training as the Government may, from time to time, direct by order.
