এস. আর. ও. নং-৩৫৫-আইন/২০২৫।—Army Act, 1952 (Act No. XXXIX of 1952) এর Section 176A তে প্রদত্ত ক্ষমতাবলে সরকার, Army Equipment Regulations, 1988, Volume II-(Instructions) এর নিম্নরূপ সংশোধন করিল, যথা :—

উপরি-উক্ত Regulations এর—

১। CHAPTER 2 (SUPPLY OF ORDNANCE STORES) এর Section 5- ISSUE OF ORDNANCE STORES ON LOAN শিরোনামাধীন—

(ক) Instruction 58 এর পরিবর্তে নিম্নরূপ Instruction 58 প্রতিস্থাপিত হইবে, যথা :—

“ Competent Financial Authority

58. Sanctioning for temporary loan issues for controlled and uncontrolled stores will be the responsibility of Assistant Director of Ordnance Services, Ordnance Directorate, Army Headquarters. For permanent and semi-permanent loan, government sanction is required. Ordnance Directorate (respective sections) will be responsible for obtaining

government sanction as per procedure. The staff officer (nominated by formation commander/equivalent commander) will examine the necessity and quantities of stores required as per regulations in force and will endorse appropriate recommendations on behalf of the formation commander/equivalent commander for the loan issue if satisfied.”;

(খ) Instruction 64 এর পরিবর্তে নিম্নরূপ Instruction 64 প্রতিস্থাপিত হইবে, যথা :—

“64. Demand for loan issues will be prepared on the prescribed proforma as per Annex ‘A’ to these instructions. If the demand is for more than one item separate sheets will be prepared for stores pertaining to different Vocab/SDLES Sections/Sub Section. Similarly demands for controlled and uncontrolled stores will be prepared separately. These will be signed personally by the unit commander and after pricing by local audit officer will be submitted to Army Headquarters through Formation Headquarters. Formation Headquarters will forward the demands, duly countersigned by the staff officer (nominated by formation commander/ equivalent commander), to parent Directorates for permanent and semi-permanent loan and to Ordnance Directorates (Section concerned) for temporary loan issues. Cases of urgent nature will not be delayed if local audit officer cannot readily furnish the cost of stores demanded on loan. Cost of such stores will be assessed at Army Headquarters in consultation with Ministry of Finance (Military).”;

(গ) Instruction 66 এর পরিবর্তে নিম্নরূপ Instruction 66 প্রতিস্থাপিত হইবে, যথা :—

“ Actions at Formation Headquarters

66. On receipt of application from unit, the formation Headquarters carefully vet these and if the requirement is accepted by the formation commander as of inescapable

nature, the nominated staff officer signs it on behalf of the formation commander/equivalent commander, before the application forwarded to Army Headquarters.

The staff officer (nominated by formation commander/equivalent commander) while endorsing appropriate recommendations on behalf of the formation commander/equivalent commander will also certify that the requirement cannot be met from within the formation resources. ”।
