এস. আর. ও. নম্বর ৩৫৮-আইন/২০২৫।—গণপ্রজাতন্ত্রী বাংলাদেশের সংবিধানের ৫৫(৬) অনুচ্ছেদে প্রদত্ত ক্ষমতাবলে রাষ্ট্রপতি Rules of Business, 1996-এর নিম্নরূপ অধিকতর সংশোধন করিলেন, যথা:—

(ক) SCHEDULE-I (Allocation of Business among the different Ministries and Divisions)-এর Serial Number “23. MINISTRY OF HOME AFFAIRS” শিরোনাম এবং উপশিরোনাম “A. Public Security Division” ও তদ্ব্যবস্তিত এন্ডিসমূহ এবং উপশিরোনাম “B. Security Services Division” ও তদ্ব্যবস্তিত এন্ডিসমূহের পরিবর্তে নিম্নরূপ শিরোনাম ও এন্ডিসমূহ প্রতিস্থাপিত হইবে, যথা:—

20. Administration, supervision of Department of Fire Service and Civil Defence and Department of Narcotics Control.
21. Proscription of books and publications.
22. Prevention from the bringing into Bangladesh of undesirable Literature under Customs Act.
23. Control of carnivals, fairs, melas, gambling, betting, etc.

24. Security and Protection of VVIPs/VIPs.
25. War Injuries Scheme and War Injuries Compensation Insurance.
26. Gallantry Awards and decorations in respect of forces under its control.
27. Matters relating to The Foreigners Act., Bangladesh (Control of Entry) Act.
28. Administration of Explosive Substance Act and Explosive Act.
29. Matters related to Field Firing and Artillery Practices Act.
30. The Official Secrets Act.
31. The Control of Disorderly and Dangerous Persons (Goondas) Act.
32. Matters related to Arms Act.
33. Activities related to Police Commission.
34. Matters related to Police Awards.

45. Registration of identity of the citizen of Bangladesh, preparation and issuance of National Identity (NID) Cards, National Identity Registration Act, 2023 (Act No. XL of 2023) and other functions related thereto.
46. Administration of Passport and Visa wing in Bangladesh Missions abroad and appointment of officers and staff thereof.”;
