NOTIFICATION

Dagca, the 5th January, 1977.

No. S.R.O. 2-L/77.—In exercise of the powers conferred by section 5 of the Land Development Tax Ordinance, 1976 (Ordinance No. XLII of 1976), the Government is pleased to make the following amendment in the Land Development Tax Rules, 1976, namely:—

In the aforesaid Roles,--

- (I) in rule 2, clause (d) shall be omitted;
- (2) in rule 4, for sub-rule (2) the following shall be substituted, namely:-
 - "(2) If any land is used partly for commercial or industrial purposes and partly for residential or other purposes, the land shall be classified as land for industrial or commercial purposes and shall be ussessed accordingly.
 - (3) If as a result of transfer or devolution, a plot is sub-divided and possessed by more than one person without effecting separation of jama, such plot shall be treated as one plot for the purpose of assessment under these rules.":

- (3) rule 5 shall be omitted;
- (4) in rule 7,--
 - (a) for sub-rule (1) the following shall be substituted, namely:-
 - "(1) Any person aggrieved by classification of land or assessment made by the Revenue Officer may prefer an appeal briefly stating the grounds of such appeal to the appellate authority.";
 - (b) after sub-rule (2), the following shall be added, namely:-
 - "(3) Every appeal shall be accompanied by a process fee in court, fee stamps as specified below:—
 - (a) for each notice whether directed to one or more persons where such persons reside in the same mouza, Taka one and twentyfive poisha only; and
 - (b) where the notice is to be served in different mouzas, a separate fcc for each mouza shall be charged at the rates as in clause (a)."; and
 - (5) after rule 9, the following shall be inserted, namely:-
 - "9A. Special powers of Deputy Commissioner.—Notwithstanding anything in these rules, the Deputy Commissioner shall---
 - (a) have powers to correct obvious errors, such as, arithmetical or clerical errors, before or after the final publication of the assessment roll; and
 - (b) on receipt of an application or on receipt of an official report for correction of any entry that has been procured by fraud in the assessment roll either before or after final publication thereof, after consulting the relevant records and making such other enquiries as he deems necessary, direct excision of the fraudulent entry."

OFFICE MEMORANDUM

Dacca, the 4th January, 1977. °

No. PIII/21-01-57/63(6).—The Government has been pleased to appoint an Expert Commission consisting of the following members to analyse the problems being faced by sugar industry and recommend ways and means for improvement of efficiency in this sector:—

- Mr Y. S. Ahmed, House No. 163, Road No. 13/3, Dhanmondi Residential Area, Dacca—Chairman.
- (2) Mr Mohammad Ali, Chairman, Bangladesh Sugar and Food Industries Corporation—Member.

- (3) Mr Ismail Hussain, O. S. D., Bangladesh Steel and Engineering Corporation—Member.
- (4) Mr Kamaluddin, Additional Director of Agriculture-Member.
- (5) Mr A. E. A. Monim, Chief Engineer, Bangladesh Steel and Engineering Corporation—Member-Secretary.

The terms of reference of the Commission will be as follows:

- (1) To study and submit-appropriate recommendations in the following fields:—
 - (a) Organisational set up of sugar mills under the Bangladesh Sugar and Food Industries Corporation and the existing system of operation of these enterprises;
 - (b) Liquidity position of the enterprises;
 - (c) Existing system of obtaining supply of sugarcane and the desirability of continuance of the Molasses Control Order in the interest of getting the required quantity of cane for crushing in the mills;
 - (d) Capital structure of the enterprises and their adequacy to meet their requirements of the enterprises;
 - (e) Labour and man-power position in the Corporation and the enterprises;
 - (7) Itemwise budget of Corporation Head Office and Establishment;
 - (g) Production planning;
 - (h) Inventory control;
 - (i) Detailed cost of production of sugar;
 - (j) Distribution system of sugar;
 - (k) Productivity of each enterprise. The problem of anomaly in percentage recovery of sugar in different mills;
 - (1) The question of import of spares vis-a-vis use of indigenous ones;
 - (m) Economic viability of the sector as a whole and of the individual enterprises.
- (2) To examine the following possibilities:-
 - (a) To examine the effectiveness and functioning of Sugar Research Institute at ISHURDI and recommend measures how it can offer total technical advisory support to all sugar mills. Suggest organisational changes if necessary to achieve aim;
 - (b) Export of some quantity of sugar and grant of appropriate export bonus which can be used for import of spares by the sugar sector;
- (3) To recommend measures for improving the efficiency of the mills and reducing the cost of production particularly the wastage percentage;
- (4) To recommend measures to cut-out overheads in the Corporation and Enterprise Head Offices and introduce austerity;

(5) To recommend other measures not mentioned above which are considered to be relevant for improvement of the efficiency of the sugar mills.

The Commission will have the authority to (a) call for person/persons associated directly or indirectly with sugar industry, (b) check any document/paper connected with sugar industry, (c) Co-opt any member considered necessary by the Commission, (d) visit any sugar industry.
