ORDER

Dacca, the 10th January 1981

No. S.R.O. 8-L/81/LIUVII/5(1)/81.—Whereas the workers of the Hotel Golden Gate, Dacca, have gone on strike with effect from the 10th December, 1980;

And whereas the continuance of the said strike is causing serious hardship to the community;

Now, therefore, in exercise of the powers conferred by the proviso to sub-section (2) of section 32 of the Industrial Relations Ordinance, 1969 (Ord. No. XXIII of 1969), the Government is pleased to prohibit the aforesaid strike of the workers of the hotel Golden Gate, Dacca and to refer the dispute to the First Labour Court, Dacca, for adjudication in pursuance of provisions of sub-section (3) of the said section.
