No. S.R.O. 22-L/81.—The following draft of certain further amendments in the Income-tax Rules, which the National Board of Revenue proposes to make in exercise of the powers conferred by section 59 of the Income-tax Act, 1922 (XI of 1922), is hereby published as required by sub-section (4) of the said section for the information of all persons likely to be affected thereby, and notice is hereby given that the said draft will be taken into consideration on or after the 18th day of February, 1981. Any objection or suggestion which may be received from any person in respect of the said draft on or before the date specified above will be considered by the Board.

In the aforesaid Rules, in rule 50, in sub-rule (2), in clause (c), the words "under a Production Sharing Agreement with the Government" shall be *omitted*.

In the aforesaid Notification, against Tariff Heading No. 19.02 in column (1), and the entries relating thereto in columns (2) and (3) the following shall be substituted, namely:—

“19.02 Preparations of flour, meal, starch or malt extract, of a kind used as infant food or for dietetic or culinary purposes, containing less than 50 per cent by weight of cocoa 5 per cent *ad val.*”

O. 24-L/81/23-Poll(I).—Whereas the Government is of the opinion that it is expedient for the public safety to prohibit absolutely the manufacture, possession and importation of explosives within the limits of Madaripur and Shariatpur Subdivisions of Faridpur district and Sadar North Subdivision of Bakergonj district;

Now, therefore, in exercise of the powers conferred by clause (a) of subsection (1) of section 6 of the Explosives Act, 1884 (IV of 1884), the Government is pleased to prohibit absolutely the manufacture, possession and importation of explosives within the limits of Madaripur and Shariatpur Subdivisions of Faridpur district and Sadar North Subdivision of Bakergonj district.

-2. This notification shall remain in force for a period of one year from the date of its publication in the official Gazette.
