# OFFICE OF THE PRESIDENT, SUMMARY MARTIAL LAW COURT AT RAJSHAHI.

#### PROCLAMATION

#### G. R. Case No. 1795/74

Whereas it has been made to appear to me that (1) Eshahar, son of Manik Mondal of Patiakandi, P.S. Charghat, Dist. Rajshahi and (2) Poresh Chandra Roy, son of late Niranjon Roy of 35 No. Gowalnagar, P. S. Kotwali, Dist. Dacca, absconding accused in Charghat P.S. Case No. 5, dated 14th December, 1974, are required for the purpose of trial in the Summary Martial Law Court at Rajshahi under section 156(89) Customs Act read with 25B Special Powers Act, 1974;

And whereas this Court have reason to believe that the accused persons (1) Eshahar, son of Manik Mondal of Patiakandi, P.S. Charghat, Dist. Rajshahi and (2) Poresh Chandra Roy, son of late Niranjan Roy of 35 No. Gowalnagar, P. S. Kotwali, Dist. Dacca, are absconding themselves to avoid appearance or arrest for the purpose;

Now, therefore, in exercise of the powers conferred under section 156(89), Customs Act read with 25B Special Powers Act, 1974, this Summary Martial Law Court at Rajshahi do hereby direct—

(1) Eshahar, son of Manik Mondal of Patiakandi, P.S. Charghat, Dist. Rajshahi, (2) Poresh Chandra Roy, son of late Niranjan Roy of 35 No. Gowalnagar, P.S. Kotwali, Dist. Dacca, to appear in this Court at Rajshahi on the 1st day of February, 1977-at 10 00 hours in connection with Charghat P.S. Case No. 5, dated 14th December, 1974, G.R. Case No. 1795/74, failing which they shall be tried in absentia and their properties may be forfeited to the Government.
