No. S.R.O. 25-L/78/2-Excise.—In exercise of the powers conferred by the provisions contained in the third column against item No. 8II(2)(i)(a) of the First Schedule to the Excises and Salt Act, 1944 (I of 1944), the Government is pleased

to make the following further amendment in this Ministry's Notification No. S.R.O. 214-L/75/10/7^c-Excise, dated the 23rd June, 1975, namely:—

In the aforesaid Notification, in the Table, for serial No. 6 in column 1 and the entries relating thereto in columns 2, 3 and 4 the following shall be *substituted*, namely:—

(ii) cigarettes supplied to Bangladesh Navy for consumption by its personnel on board its vessels. Nil."

Dacca, (2) Abdul Karim Bepari, son of late Elahi Baksha of Aksha, P.S. Nawdia, Dist. Faridpur, at present Drum Metal Ltd., Tejgaon, Dacca, (3) Reazul Haque, son of Mir Bazlur Rahman, Store Officer, Drum Metal Ltd., Dacca, are required for the purpose of trial in the Special Martial Law Court No. II, Ganabhaban, Dacca, u/s. 380/409, B.P.C.;
