No. S.R.O. 30-L/81/S-VI/3R-2/81/17.—In exercise of the powers conferred by section 146 of the Paurashava Ordinance, 1977 (Ord. XXVI of 1977), read with items 18 and 19 of the Third Schedule of that Ordinance, the Government is pleased to make the following further amendments in the Municipal Committees (Assessment and Collection of Octroi) Rules, 1961, namely:—

In the aforesaid Rules,—

- (1) throughout the rules, unless otherwise provided,—
 - (a) for the words "Municipal Committee" wherever occurring the word "Paurashava" shall be substituted; and
 - (b) for the word "Committee" wherever occurring the word "Paurashava" shall be substituted;
- (2) in rule 1,—
 - (a) in sub-rule (1), for the words "East Pakistan Municipal Committees" the word "Paurashava" shall be substituted; and
 - (b) in sub-rule (2), for the words "Provincial Government" the word "Government" shall be substituted;

(3) in rule 2,—

(a) in sub-rule (1),—

(i) for clause (d) the following shall be *substituted*, namely:—

“(d) ‘Paurashava’ means the Paurashava concerned;” and

(ii) for clause (g) the following shall be *substituted*, namely:—

“(g) ‘Ordinance’ means the Paurashava Ordinance, 1977;” and

(b) in sub-rule (2), for the word and figure “section 3” the word and figure “section 2” shall be *substituted*;

(4) in Schedule I, in items specified under Class VIII, for item 11 in the first column and the entries relating thereto in the second column the following shall be *substituted*, namely:—

“11. Miscellaneous—

(a) Machines and Machineries and their spare parts $\frac{1}{4}$ per cent.
ad valorem.

(b) Thermosflasks, Fire-extinguishers, Gas plants, 1 per cent.
electric and scientific goods and their spare parts *ad valorem*.”.

NOTIFICATION

Dacca, the 16th January, 1981

No. Sec.XI/4C-7/78/37-Edn.—Whereas Mr M. A. Bari while working as Principal, Chittagong Engineering College, was nominated by the Government for deputation as the Faculty Consultant, Colombo Plan Staff College, Singapore, and an office order regarding his said deputation was accordingly issued, *vide* No. SV/4A-3/78(839)-Edn., dated the 14th November 1978, but the deputation order did not specify any date on which Mr M. A. Bari was to make over charge of the College and leave for Singapore;

2. And whereas the Chittagong Engineering College was then passing through a serious crisis of students unrest for which the Director of Technical Education requested Mr M. A. Bari, *vide* his telegram No. Estt(G)/1203, dated the 21st November 1978, to defer his departure for Singapore till normalization of the situation in the College, and although he received the said telegram and

acknowledged its receipt, *vide* his Memo No. 1493, dated the 25th November 1978, Mr M. A. Bari made over charge of the College to Mr S. M. Rashid, Associate Professor, without prior approval either of the Director of Technical Education or the Ministry of Education, and left for Singapore on 29th November 1978;

3. And whereas the aforementioned action of a Government Servant of Mr M. A. Bari's seniority and status amounts to gross misconduct which is punishable under Rule 3(b), read with rule 4(2) or (3), Part II of the Government Servants (Discipline and Appeal) Rules, 1976;

4. And whereas Mr M. A. Bari, formerly Principal, Chittagong Engineering College, now working as Faculty Consultant, Colombo Plan Staff College, Singapore, was charged with misconduct, and on the nomination of the Establishment Division, Syed Mannan Bakhs, Additional Secretary (Enquiries), Establishment Division, was appointed Inquiry Officer under rule 10 of the Government Servants (Discipline and Appeal) Rules, 1976 for holding inquiry under rule 7(2) of the said Rules;

5. And whereas the Inquiry Officer duly held inquiry on the charges brought against the delinquent officer by examining witness on behalf of the prosecution and defence who were also cross-examined, and the delinquent officer was also heard in person;

6. And whereas on completion of the inquiry the Inquiry Officer submitted his report under sub-rule (4) of rule 7 of the Government Servants (Discipline and Appeal) Rules, 1976;

7. And whereas after considering the report submitted by the Inquiry Officer and the circumstances of the case I am of the opinion that the charge of misconduct, as defined in clause (c), rule 2 of the Government Servants (Discipline and Appeal) Rules, 1976 has been proved beyond reasonable doubts against the delinquent officer;

8. Now, therefore, having regard to the circumstances of the case, I am of the opinion that imposition of a minor penalty, as defined in rule 4(2) of the Government Servants (Discipline and Appeal) Rules, 1976 will meet the ends of justice.

9. I, therefore, hereby impose the penalty of censure under rule 4(2) (a) of the Government Servants (Discipline and Appeal) Rules, 1976 on Mr M. A. Bari, formerly Principal, Chittagong Engineering College, now Faculty Consultant, Colombo Plan Staff College, Singapore.
