NOTIFICATION

Dhaka, the 10th January, 1985

No. S.R.O. 34-L/85/IV-25/83.—In pursuance of the Proclamation of the 24th March, 1982, and in exercise of all powers enabling him in that behalf, the President is pleased to make the following rules, namely:—

THE TAHSILDERS AND ASSISTANT TAHSILDERS (GOVERNMENT ACQUIRED ESTATES) RECRUITMENT RULES, 1984.

1. **Short title.**—These rules may be called The Tahsilders and Assistant Tahsilders (Government Acquired Estates) Recruitment Rules, 1984.

2. **Definitions.**—In these rules, unless there is anything repugnant in the subject or context,—

- (a) "appointing authority" means the Deputy Commissioner of the district;
- (b) "probationer" means a person appointed on probation to a specified post;
- (c) "recognised Board" means a Board of Intermediate and Secondary Education established by or under any law for the time being in force and includes any other Board declared by the Government to be a recognised Board for the purposes of these rules;
- (d) "requisite qualification" in relation to a specified post, means the qualification laid down in the Schedule in relation to that post;
- (e) "Schedule" means the Schedule annexed to these rules; and
- (f) "specified post" means a post specified in the Schedule.

3. **Procedure for recruitment.**—(1) Appointment to a specified post shall be made—

- (a) by direct recruitment;
- (b) by promotion; or
- (c) by absorption of staff of Vested Property Cell.

(2) No person shall be appointed to a specified post unless he has the requisite qualification and, in the case of direct recruitment, he is also within the age limit laid down in the Schedule for that post :

Provided that the upper limit of age may be relaxed in the case of a person who is in the service of the Republic or of a local authority or in the Vested Property (L & B) Cell.

4. **Appointment by direct recruitment.**—(1) No appointment to a specified post by direct recruitment shall be made except upon the recommendations of the Divisional Selection Board constituted by the Government for the purpose.

(2) No person shall be eligible for appointment to a specified post by direct recruitment, if he—

- (a) is not a citizen of Bangladesh, or a permanent resident of, or domiciled in, Bangladesh and also if he is not a permanent resident of the district for which appointment will be made; and
- (b) is married to, or has entered into a promise of marriage with, a person who is not a citizen of Bangladesh.

(3) No appointment to a specified post by direct recruitment shall be made until—

- (a) the person selected for appointment is certified by a medical officer duly authorised by the Government in this behalf to be medically fit for such appointment and that he does not suffer from any such organic defect as is likely to interfere with the discharge of the duties of the specified post; and
- (b) the antecedents of the person so selected have been verified through appropriate agencies and found to be such as do not render him unfit for appointment in the service of the Republic.

(4) No person shall be recommended for appointment to a specified post unless—

- (a) he applied in such form, accompanied by such fee and before such date, as may be notified by the appointing authority while inviting applications for the specified post; and
- (b) in the case of a person already in Government service or in the service of a local authority or in the service of Vested Property (L & B) Cell he applied through his official superior.

5. **Appointment by promotion.**—(1) Appointment by promotion to a specified post shall be made on the recommendation of the Divisional Selection Board constituted by the Government or such other Board as may be constituted the Government from time to time for the purpose.

(2) A person shall not be eligible for appointment by promotion to a specified post, if he has unsatisfactory records of service.

6. Probation.—(1) Persons selected for appointment to a specified post against a substantive vacancy shall be appointed on probation—

- (a) in the case of direct recruitment, for a period of two years from the date of substantive appointment; and
- (b) in the case of promotion, for a period of one year from the date of such appointment:

Provided that the appointing authority may, for reasons to be recorded in writing, extend the period of probation by a period or periods so that the extended period does not exceed two years in the aggregate.

(2) Where, during the period of probation of a probationer, the appointing authority is of opinion that his conduct and work is unsatisfactory or that he is not likely to become efficient, it may before the expiry of that period—

- (a) in the case of direct recruitment, terminate his service; and
- (b) in the case of promotion, revert him to the post from which he was promoted.

(3) After the completion of the period of probation including the extended period, if any, the appointing authority—

- (a) if it is satisfied that the conduct and work of the probationer during his period of probation has been satisfactory, shall, subject to the provisions of sub-rule (4), confirm him; and
- (b) if it is of opinion that the conduct and work of the probationer during that period was not satisfactory, may—
 - (i) in the case of direct recruitment, terminate his service; and
 - (ii) in the case of promotion, revert him to the post from which he was promoted.

(4) A probationer shall not be confirmed in a specified post until he has passed such departmental examination and undergone such training as the Government may, from time to time, direct by order.

নং এস, আর, ও, ৩৩-এল/৮৫—সেহেতু সরকার মনে করেন যে নিম্ন তফসীল বর্ণিত নৌজাগুলির আস্ততুল্ল আবাদী জমি, অতঃপর তফসীলতুল্ল নৌজা বলিয়া অভিহিত, পানি উন্নয়ন বোর্ড কর্তৃক সরবরাহকৃত সেচ দ্বারা উপকৃত হইতেছে বা হইতে পারে;

সেহেতু বাংলাদেশ পানি সেচকর অধ্যাদেশ, ১৯৮৩ (১৯৮৩ সনের ৩১ নম্বর অধ্যাদেশ)-এর ৪র্থ ধারার (১) উপ-ধারায় প্রসঙ্গ ফলতাবলে সরকার তফসীলতুল্ল নৌজাগুলিতে প্রত্যেক শস্য নৌসুমের জন্য নিম্নবর্ণিত ধারে সেচকর আরোপের সিদ্ধান্ত ঘোষণা করিতেছেন, যথা :—

শস্য নৌসুম ।	একর প্রতি সেচকর ।
খরিক-১ (মার্চ হইতে জুন)	২৫০' ০০
খরিক-২ (জুলাই হইতে অক্টোবর)	১০০' ০০
রবি (নভেম্বর হইতে ফেব্রুয়ারী)	১৫০' ০০

তবে শর্ত থাকে যে, এককালীন ধোক সরবরাহকৃত পানির ক্ষেত্রে প্রতি একর ইঞ্চি পানির জন্য ২০' ০০ (বিশ) টাকা ধারে সেচকর ধার্য করা হইবে।

আরও শর্ত থাকে যে, অনাবাদী কোন জমির উপর সেচকর প্রযোজ্য হইবে না।

উপরিউক্ত সেচকর আরোপের ফলে ক্ষতিগ্রস্ত হইতে পারে একর জমিতে রাখবান কোন ব্যক্তি ইচ্ছা করিলে উক্ত জমি সেচকর আরোপের এলাকাতুল্লির বিকল্পে আপত্তি উত্থাপন করিতে পারেন।

ব্যাখ্যা:

(ক) এই বিজ্ঞপ্তিতে “ধোক সরবরাহ” বলিতে পুকুর বা জলাধার নাওজুদের উদ্দেশ্যে যে পানি এক নাগাড়ে সরবরাহ করা হইবে তাহাকে বুঝাইবে।

(খ) “একর ইঞ্চি পানি” বলিতে এক একর জমিতে এক ইঞ্চি গভীরতায় আয়তন বিশিষ্ট পানির পরিমাণ বুঝাইবে।

NOTIFICATION

Dhaka, the 7th January, 1985

No. 05-5/1/85-CS.—The Government have decided to form an Inquiry Committee to inquire into the incidents at Char Afzal Fakira (Bagardona) and the circumstances leading to the arrests of 33 Mokhtijoddahs of Ramgoti Upazila Mukhtijoddah Bohumukhi Samabaya Samity Limited, district Lakshhipur, and the subsequent losses of their crops, with the following officials:—

2. The terms of reference of the inquiry are as below :

- (i) to inquire into the incidents of at Ramgoti Upazila in connection with the land of Char Afzal Fakira (Bagardona) and subsequent arrest of 33 Mokhtijoddahs of Ramgoti Upazila and the losses of their crops ;
- (ii) to identify lapses/excesses on the part of any agency/person and fix up the responsibility ;
- (iii) to suggest demarcation of the boundary of the disputed land of Char Afzal Fakira ; and
- (iv) to recommend measures to prevent recurrence of such incidents and any other matter considered relevant.

3. The Committee shall Complete the inquiry and submit its report within one month from the date of the issue of this notification.
