NOTIFICATION

Dacca, the 29th January, 1981

No. S.R.O. 33-L/81.—The following draft of certain further amendments to the Bangladesh Chartered Accountants Bye-laws, 1973, which the Council of the Institute of Chartered Accountants of Bangladesh proposes to make in exercise of the powers conferred by clause (1) of Article 28 of the Bangladesh Chartered Accountants Order, 1973 (P.O. No. 2 of 1973), with the approval of the Government, is published as required by clause (3) of that Article for the information of all persons likely to be affected thereby, and notice is hereby given that the draft will be taken into consideration after fifteen days from the date of its publication in the official Gazette.

Any objection or suggestion which may be received from any person in regard to the said draft within the period specified will be considered by the Council:

**Draft Amendments**

In the aforesaid Bye-laws,—

(1) in bye-law 68, in clause (c), for sub-clause (iii) the following shall be substituted, namely:—

“(iii) is at least a second class graduate of a recognised University having secured—

(a) at least one first division either in the Secondary School Certificate or Higher Secondary Certificate Examination of a recognised Board; or

- (b) at least two second divisions in the Secondary School Certificate and Higher Secondary Certificate Examinations of a recognised Board; or”;
- (2) in bye-law 80, in paragraph (1),—
- (a) in clause (a), for the colon at the end the semi-colon and the word “; and” shall be *substituted*;
- (b) in clause (b), for the colon at the end the semi-colon and the word”; or” shall be *substituted* and thereafter the following new clause (c) shall be *added*, namely:—
- “(c) he has already completed service as an articled clerk, outside Bangladesh, with a member of the Institute of Chartered Accountants in England and Wales entitled to train, under the rules of that Institute, articled clerks and has produced documentary evidence to that effect;” and
- (c) the fifth proviso shall be *omitted*;
- (3) in bye-law 90, in paragraph (2), in the second proviso, the words, figures and brackets “before completing six months’ service as an articled student as required under the fifth proviso to paragraph (1) of bye-law 80” shall be *omitted*; and
- (4) in bye-law 93, in paragraph (2), in the second proviso, the words, figures and brackets “before completing six months’ service as an articled student as required under the fifth proviso to paragraph (1) of bye-law 80” shall be *omitted*.
