NOTIFICATION

Dacca, the 15th February 1978.

No. S.R.O. 39-L/78/119-MF/S-7/IC-3/77.—In exercise of the powers conferred by sub-clause (2) of clause 7 of the Foodstuffs Price Control and Anti-Hoarding Order, 1953, and in supersession of this Ministry's Order S.R.O. No. 350-L/77/8/855-MF/S-7/IC-3/77, dated the 28th November, 1977, the Government is pleased to direct that no rice miller including a husking miller situated outside 10 mile border-belt of Bangladesh shall—

- (a) Keep in his possession or under his control any quantity of paddy for more than 30 days from the date of his taking possession or control of the paddy; and
- (b) Keep in his possession or under his Control any rice after conversion of the paddy in the possession or under the control of a miller under (a) above or otherwise acquired for more than 7 days from the date of conversion or, as the case may be, the acquisition.
