(Customs)

Dacca, the 4th March 1978.

No. S.R.O. 45-L/8/399/E/Cus.—In exercise of the powers conferred by section 19 of the Customs Act, 1969 (IV of 1969), the Government is pleased to exempt all drugs, medicines, equipments and chemicals imported by the Diabetic Association of Bangladesh from payment of the whole of the Customs duties chargeable thereon on the following conditions, namely—

- (a) the Diabetic Association of Bangladesh shall, in respect of each consignment of abovementioned imported goods, furnish an undertaking to the Collector of Customs to the effect that the imported drugs, medicines, equipments and chemicals are essentially required for the treatment of diabetic patients or for use in its laboratory; and
- (b) the imported goods, shall not be sold or shall not be used except for the purposes specified at (a) above.

No. S.R.O. 46-L/78.—In exercise of the powers conferred by sub-section (1) of section 7 of the Sales Tax Act, 1951 (III of 1951), the Government is pleased to exempt all equipments and chemicals imported by the Diabetic Association of Bangladesh from payment of the sales tax payable under the aforesaid Act on the following conditions, namely—

- (a) the Diabetic Association of Bangladesh shall, in respect of each consignment of equipments and chemicals, furnish an undertaking to the Collector of Customs to the effect that the imported chemicals and equipments are essentially required for the treatment of diabetic patients or for use in its laboratory; and
