## IN THE COURT OF THE SUMMARY MARTIAL LAW COURT, DACCA ML, GR No. 109/76.

Whereas it has been made to appear to the court that accused A.K.M Shahidullah, Godown Inspector, Pubali Bank, Sadarghat Branch, P. S. Kotwali, Dacca, son of Mvi Abdul Hagh Bhuyan, Vill. Nurpur, P.S. Chagalnia, Dist. Noakhali, is required for the purpose of trial in the Summary Martial Law Court, Dacca under M. L. R. 16 and 17 in connection with Kotwali P.S. Case No. 9, dated the 3rd August 1976, under M. L. R. 16 and 17;

And whereas the Court has reason to believe that the said accused person is absconding and concealing himself to avoid appearance or arrest for the said purpose;

The aforesaid accused is directed to appear in the Summary Martial Law Court, Dacca Collectorate Court Building, Dacca, on 22nd February 1977, failing which he will be tried in absentia and his property part/whole may be forfeited to the State.

## ML. GR. C/No. 110/76.

Whereas it has made to appear to the court that the accused persons (1) Mosaraf Hossain alias Nanto, (2) Mohidur Rahman alias Banto, (3) Sohidur Rahman alias Minto, all sons of late Mojibur Rahman, 359, Madhubag "Rahman Manjil" P.S. Tejgaon, Dist. Dacca, are required for the purpose of trial in the Summary Martial Law Court, Dacca Collectorate Court Bilding, Dacca, under M.L.R. 10 (a) in connection with the Tejgaon P.S. Case No 80 (7)/76;

And whereas the court has reason to believe that the said accused persons are absconding and concealing themselves to avoid appearance or arrest for the said purpose;

The aforesaid accessed persons are directed to appear in the Summary Martial Law Court, Dacca Collectorate Court Building, Dacca, on the 25th February 1977 at 09-30 hours positively, failing which they will be tried in absentia and their property part/whole may be confiscated to the State.

Whereas it has made to appear to the Court that accused C/No. 6773. Tobarak Hossain, son of late Kalu Majhi of village Naogaon, P. S. Gosairhat, Dist. Fari lpur, at present Police Constable No. 6773 of S. A. F. Rajarbagh, Dacca, is required for the purpose of trial in the Summary Martial Law Court, Dacca under M.L.R. 11 in connection with Tejgaon P. S. Case No. 67(1)/76;

And whereas the Court has reason to believe that the said accused person is absconding and concealing himself to avoid appearance or arrest for the said purpose;

The aforesaid accused person is directed to appear before the Summary Martial Law Court, Dacca Collectorate Court Building, Dacca on or before 17th day of February 1977, failing which he will be tried in absentia and his property part/whole will be forfeited to the State.
