Martial Law Case No. GR 1256/74 [Sreemangal P.S. Case No. 25(10)74]

Whereas it has been made to appear to me that the accused persons specified in the schedule below hereinafter referred to as the said accused persons are required for the purpose of trial in Summary Martial Law Court No. 18, Sylhet;

And whereas the Court has reason to believe that the said accused Asman Ali, in the case abovementioned, is absconding or concealing himself to avoid appearance or arrest for the said purpose;

Now, therefore, in exercise of the power conferred by Regulation 2(11) of the Martial Law Regulation No. 1 of 1982, this Summary Martial Law Court No. 18, Sylhet, do hereby direct the aforesaid accused person to appear in this Court at 09:00 hrs. on 28th February 1984 in Case No. SGR 93/83 [Kotwali P.S. Case No. 23(7)83], failing which he will be tried *in absentia* and his properties, both movable and immovable, may be forfeited to the Government.
