নং এস. আর. ও ৬৩-আইন/৮৯—Army Act, 1952 এর Section 176-এ প্রদত্ত ক্ষমতাবলে সরকার Army Leave Rules এ নিম্নে বর্ণিত সংশোধন করিলেন যথাঃ

উপরি-উক্ত Rules এ,—

(a) Rule 40 এর পরে নিম্নোক্ত rule সন্নিবেশিত হইবে যথাঃ—

“40. A. Leave Preparatory to Retirement and grant of lump amount in lieu of Leave left over to Commissioned Officers of the Armed Forces : The Commissioned Officers in addition to Leave Preparatory to Retirement (LPR), as admissible under these rules, shall be entitled to a lump amount in cash in lieu of leave left over after availing of LPR, not exceeding 12 months pay on the basis of rank pay drawn immediately before commencement of LPR. The lump amount is payable immediately after commencement of LPR.

2. Those who retire without availing of LPR shall also be entitled to the above benefit. In their case, the lump amount in cash in lieu of leave left over at the time of retirement, not exceeding 12 months pay to be calculated on the basis of rank pay drawn immediately before retirement, shall be payable after retirement.

3. For the purpose of granting the benefit, entitlement of Furlough will be 30 days for each completed year of service and accumulation of such leave will be without any limit for all Commissioned Officers. For this purpose, Furlough availed of (inclusive of Furlough availed of during LPR, if any) during service under rule 36, shall be deducted and conversion of the balance shall be allowed at the rate of one day of leave of full pay for two days of Furlough left over/unavailed for the purpose of this rule irrespective of the provisions in the existing Leave Rules.

4. In the event of death (on or after 1-6-1984) before retirement, the lump amount in lieu of leave left over, for the purposes of this rule, will be calculated as if the Government servant retired on the date of death and the amount due to the deceased shall be payable to his family as defined in the pension rules."

(খ) rule 65 এর পরে নিম্নরূপ Rules সন্নিবেশিত হইবে, যথাঃ—

"65.A. **Leave Preparatory to Retirement and grant of lump amount in lieu of leave left over to Honorary Commissioned Rank including Non-Combatants (Enrolled) and MODC Personnel:** Honorary Commissioned Officers/JCOs and personnel below Commissioned rank including NCs(E) and MODC personnel, in addition to Leave Preparatory to Retirement (LPR) as admissible under these rules shall be entitled to a lump amount in cash in lieu of leave left over after availing of LPR, not exceeding 12 months pay on the basis of rank pay drawn immediately before commencement of LPR. The lump amount is payable immediately after commencement of LPR.

2. Those who retire without availing of LPR shall be entitled to the above benefit. In their case, the lump amount in cash in lieu of leave left over at the time of retirement, not exceeding 12 months pay to be calculated on the basis of rank pay drawn immediately before retirement, shall be payable immediately after retirement.

3. For the purpose of granting this benefit, Annual Accumulation of Privilege leave, as admissible under the existing Leave Rules, may be @ maximum 30 days for each completed year of service and such accumulation shall be without limit. The period of accumulated Privilege leave availed of as LPR, if any, shall be deducted from the said accumulated Privilege leave and the balance shall be treated as leave unavailed/left over for the purpose of this rule irrespective of the provision in the existing Leave Rules.

4. In the event of death (on or after 1-6-1984) before retirement, the ~~leave~~ amount in lieu of leave left over, for the purpose of this rule, will be calculated as if the Government servant retired on the date of death and the amount due to the deceased shall be payable to his family as defined in the pension rules”.

কি এন, অর, ও ৬৪-আইন/৮৯— Army 'Act, 1952 (XXXIX of 1952) এর section 176 তে প্রদত্ত ক্ষমতাবলে সরকার Army Leave Rules, 1975 নিম্নরূপ সংশোধন করিলেন, যথা :

উপরি-উক্ত Rules এর rule 2 তে :—

(ক) “(a),(b) and (c)” বহুভাষী, অক্ষরগুলি ও শব্দের পরিবর্তে “(a) and (b)” বহুভাষী, অক্ষরগুলি ও শব্দ প্রতিস্থাপিত হইবে ;

এবং

(খ) “Exception (c)” শব্দ, বহুভাষী ও অক্ষরের পরিবর্তে “Exception (b)” শব্দ, বহুভাষী ও অক্ষর প্রতিস্থাপিত হইবে।
