NOTIFICATION

Dacca, the 31st March 1978.

No. S.R.O. 66-L/78.—In exercise of the powers conferred by section 86 of the Excise Act, 1909 (Ben. Act V of 1909), the Government is pleased to make the following further amendments in the Rules for the manufacture of Ayurvedic preparations such as Mritasanjibani Sura, Mritasanjibani Sudha, etc., published under Notification No. 812-Ex., dated the 12th August 1936, namely:—

In the aforesaid Rules, in Rule 15, for the figure "25" wherever occurring the figure "42" shall be substituted.

2. This notification shall be deemed to have taken effect on the 19th December, 1974.

**MINISTRY OF MANPOWER DEVELOPMENT, LABOUR AND  
SOCIAL WELFARE.****Section VII****ORDERS****Dacca, the 1st April, 1978.**

**No. LSW VII/11(3)/78/142.**—WHEREAS the Eastern Refinery Employees Union has given under section 28 of the Industrial Relations Ordinance, 1969 (XXIII of 1969), notice of strike with effect from the 3rd April, 1978;

AND WHEREAS the Eastern Refinery is a public utility service;

AND WHEREAS it is necessary to prohibit the threatened strike;

NOW, THEREFORE, in exercise of the powers conferred by section 33 of the said Ordinance, the Government is pleased to prohibit the threatened strike.

**No. LSW VII/11(3)/78/143.**—WHEREAS on a charter of 10-point demand submitted by the Eastern Refinery Employees Union (Regd. No. EP-1337), a dispute arose between the Union and the Management of Eastern Refinery Ltd., Chittagong;

AND WHEREAS the Eastern Refinery Employees Union has served a notice of strike under section 28 of the Industrial Relations Ordinance, 1969 (XXIII of 1969), with effect from 3rd April, 1978;

AND WHEREAS the threatened strike has been prohibited under section 33 of the Industrial Relations Ordinance, 1969;

NOW, THEREFORE, in exercise of the powers conferred by sub-section (3) of section 32 of the Industrial Relations Ordinance, 1969, the dispute is referred to the Labour Court, Chittagong for adjudication.
