নং এস, আর, ও ৮৪-আইন/৮৯/শা-১১/১আর-১/৮৯/৭১—Local Government (Upazila Parishad) and Upazila Administration Reorganisation) [Ordinance, 1982 (LIX of 1982) এর section 57 এ প্রদত্ত ক্ষমতাবলে সরকার Upazila Parishad (Contracts) Rules, 1986 এ নিম্নরূপ সংশোধন করিলেন, যথা :

উপরি-উক্ত Rules এর—

১। rule 5 এ—

(ক) sub-rule (2) এর পরিবর্তে নিম্নরূপ sub-rule (2) প্রতিস্থাপিত হইবে :—

“(2) For submission of tender by the party date, time, place and also the amount or earnest money of the following rate of the estimated cost in the form of bank draft or pay order to be submitted along with the tender shall also be specified in the notice and accordingly a tender box shall be kept in the place mentioned in the notice for receiving tenders :—

(a) Tk. 25,000 upto the estimated cost of Taka one lac,

(b) Tk. 50,000 when the estimated cost of work is Taka above one lac to five lacs, and

(c) Tk. 1,00,000 when the estimated cost of work is above Taka five lacs :

Provided that every tender shall be accompanied by the requisite earnest money and any tender submitted without earnest money shall be rejected at the time of opening the tender.”;

(খ) sub-rule (4) এর পরিবর্তে নিম্নরূপ sub-rules প্রতিস্থাপিত হইবে, যথা :-

“(4) On the date and time fixed in the tender notice, the Upazila Engineer concerned and other tender receiving authorities authorized in the tender notice shall open the tenders in presence of the tenderers or their authorised representatives who may like to be present; and the Upazila Engineer concerned and other tender receiving authorities shall obtain the signature and date of the tenderers or their authorised representatives who attend the opening of the tenders on the opening moment as a token of witness.

(4A) The tenders received and opened by the Deputy Commissioner of the district and the Executive Engineer of the L.G.E.B. shall be sent by them under their signature to the Upazila Engineer concerned within forty eight hours from the time of opening the tenders in a sealed cover alongwith a statement of tenders by special messenger.”;

(গ) sub-rule (5) এর পরিবর্তে নিম্নরূপ sub-rule প্রতিস্থাপিত হইবে, যথা :

“(5) The Upazila Engineer shall prepare a comparative statement of tenders received at his office and the tenders received if any, under sub-rule (4A) and submit it to the tender Committee together with the tenders.”।

২। rule 10 এর পরিবর্তে নিম্নরূপ rule প্রতিস্থাপিত হইবে, যথা :

“10 Security.—The earnest money of the accepted tender shall be treated as security deposit for due performance of any contract into which it enters and the Parishad may specify such penalties as provided in the tender document appended to these rules for failure to fulfil the contract while the earnest money of the unaccepted tender shall be refunded after disposal of the tenders.”।

৩। rule 11 এর sub-rule (2) বিলম্বিত হইবে।

৪। Tender document "NOTICE INVITING TENDERS" এর—

(ক) Paragraph 1 এর পরিবর্তে নিম্নরূপ paragraph প্রতিস্থাপিত হইবে, যথাঃ—

"1.(a) Sealed tenders in Form.....are hereby invited from the class enlisted contractor of.....Upazila Parishad enlisted contractors of any other Upazila Parishad of the district concerned, enlisted contractors of the Zila Parishad concerned and also prequalified contractors of Local Government Engineering Bureau for the undermentioned work and will be received by the undersigned in his office and in the offices of Deputy Commissioner of the district concerned and the Executive Engineer, L.G.E.B. upto 12-00 noon on.....and will be opened by the respective receiving authority on the same day at 12-30 p.m. in presence of the tenderers or their authorised representatives who may like to remain present. Each tender shall be in a sealed cover with the name of work superscribed on it.

(b) If any tender of any contractor other than the enlisted contractor of the Upazila Parishad concerned is accepted by the Parishad he shall get himself as an enlisted contractor of that Upazila Parishad before issuance of the work order."

(খ) Paragraph 9 এ উল্লিখিত—

"at the rate of 2%" সংখ্যা এবং শব্দগুলি বিলুপ্ত হইবে।

৫। FORM-A এর সহিত সংযুক্ত "CONDITIONS OF CONTRACT" এর clause 22 এ "District Engineer" শব্দগুলির পরিবর্তে "Executive Engineer, Local Government Engineering Bureau" শব্দগুলি প্রতিস্থাপিত হইবে।

৬। FORM-B এর paragraph 1 এর প্রথম Sentenceটি বিলুপ্ত হইবে।
