GOVERNMENT OF THE PEOPLE'S REPUBLIC OF BANGLADESH  
IN THE COURT OF THE SUMMARY MARTIAL LAW COURT, DACCA.

Whereas it has been made to appear to the Court that (1) Nk. 4624, Sekander Ali, son of Md. Abed Ali of village Badekalpa, P.S. Kotwali, Dist. Mymensingh, (2) C/6354, Shapon Kumer Dhar, son of Debendra Chandra Dhar of village Rupakhali, P.S. Kotwali, Dist. Mymensingh, are required for the purpose of trial in the Summary Martial Law Court, Dacca under sections 448/376/379/342; B.P.C. in connection with Kaliganj P.S. Case No. 6(2)/76.

June, 1976, the Government is pleased to make the following further amendment in this Ministry's Notification No. S.R.O. 30/D/Cus/72, dated the 30th June, 1972, namely :—

In the aforesaid Notification, in the Table, against Heading No. 48.07 in column (1), after item (iii) in column (2) and the entry relating thereto in column (3), the following new item shall be *added*, namely:—

“(iv) Coated duplex board falling under sub-head B(ii)

100% *ad val.*”

**No. S.R.O. 94-L/77/327/D/Cus.**—In exercise of the powers conferred by section 19 of the Customs Act, 1969 (IV of 1969), and in supersession of this Ministry's Notification No. S.R.O. 247-L/75/246/D/Cus/75, dated the 12th July, 1975, the Government is pleased to make the following further amendments in this Ministry's Notification No. S.R.O. 30/D/Cus/72, dated the 30th June, 1972, namely :—

In the aforesaid Notification, in the Table,—

(a) against Heading No. 51.04 in column (1), for the item (ii) in column (2) and the entries relating thereto in column (3), the following shall be *substituted*, namely:—

“(ii) All goods falling under sub-heads A and B except suitings

175% *ad val.*

(iii) suitings falling under sub-heads A and B

125% *ad val.*”

(b) against Heading No. 55.09 in column (1), after item (vii) in column (2) and the entries relating thereto in column (3), the following shall be *added*, namely:—

“(viii) Other woven fabrics of cotton containing silk or man-made fibres

125% *ad val.*”; and

(c) after Heading No. 56.06 in column (1) and the entries relating thereto in columns (2) and (3), the following new Heading No. shall be *inserted*, namely:—

“56.07 (i) All goods falling under sub-heads A and B except suitings

175% *ad val.*

(ii) suitings falling under sub-heads A and B

125% *ad val.*”
