**Amendment**

In the Co-operative Societies Rules, 1942, in rule 25, in sub-rule (6), for the second proviso the following shall be *substituted*, namely :

“Provided that the Comilla Kotwali Thana Central Co-operative Association Ltd. may hold its general meeting with one such delegate representing each of its affiliated primary co-operative societies as is borne on the register of membership of the primary society on the 1st day of July each year”.
