No. S.R.O. 95-L/84/114-Excise.—In exercise of the powers conferred by section 12A(1) of the Excise and Salt Act, 1944 (1 of 1944), the Government is pleased to make the following further amendments in this Division's Notification No. S.R.O. 225-L/83/94-Excise, dated the 30th June, 1983, namely:—

In the aforesaid Notification,—

(1) in TABLE 1, for item No. 04-09 in column 1 and the entries relating thereto in columns 2 and 3, the following shall be *substituted*, namely:—

“04-09 (a) Medicine or medicinal products, all sorts, manu- Nil.
factured on a cottage industry basis.

(b) Medicinal contraceptive, sera and vaccine Nil.”

(2) for the words and brackets “Member (Excise)” at the end the words “Joint Secretary” shall be *substituted* and shall be deemed to have always been so substituted.
