No. S.R.O. 109-L/77.—In exercise of the powers conferred by sub-section (1) of section 7 of the Sales Tax Act 1951 (III of 1951), the Government is pleased to make the following further amendment in the Ministry of Finance Notification No. 7, dated the 27th June, 1951, namely:—

In the aforesaid Notification, *after* item No. 81, the following new item shall be added, namely:—

“82. Cotton yarn below 80 counts falling under the Heading Nos. 55·05 and 55·06 of the First Schedule to the Tariff Act, 1934 (XXXII of 1934), provided these are imported into Bangladesh under the Wage Earner Scheme.”
