No. S. R. O. 123-L/80/232-MF/S-7/IS-4/77.—In exercise of the power conferred by sub-paragraph (2) of paragraph 1 of the Rationing (Establishments) Inquiry Order, 1949, the Government is pleased to make the following further amendments in the late Food and Agriculture Department, Food Branch, Notification No. 1227-FD, dated the 15th February, 1956, namely:

In the aforesaid Notification,—

(1) in paragraph 1, *after* sub-paragraph (26), the following new sub-paragraph shall be *added*, namely:—

“(27) The following areas of Gulshan Police Station in the district of Dacca:—

- (a) the villages Shahjadpur, Kalachandpur, Nadda and part of Nayana-gar within Mauza Bhatara bearing jurisdiction list No. 294, comprising plot Nos. 1 to 318, 326, 327, 331 to 341, 364, 365 and 367 to 380 of sheet No. 1 and plot Nos. 727 to 732, 737 to 740, 754 to 961, 963 to 969, 973 to 975, 977 to 981, 986 to 989, 1003, 1004, 1049 to 1072, 2869, 2870 and 2872 to 2878 of sheet No. 2;

South: Covered by Statutory Rationing Area of Mouza Badda bearing jurisdiction list No. 291 and non-rationed area of Satarkul Union;

East : Covered by non-rationed area of Mouza Nandipura, J. L. No. 317.

West : Covered by Statutory Rationing Area of Mouza Ullan, J. L. No. 290 and Mouza Shahar Khilgaon, J. L. No. 287;" and

- (2) in paragraph 2, *after* sub-paragraph (7), the following new sub-paragraphs shall be *added*, namely:

"(8) The part of Mouza Sitalakhya, bearing jurisdiction list No. 181, covered by cadastral survey plot Nos. 1 to 480 within the police-station Narayanganj in the district of Dacca.

(9) The part of Mauza Masinabadh, bearing jurisdiction list No. 179, covered by cadastral survey plot Nos. 1 to 62 within the police-station Narayanganj in the district of Dacca."

East : Covered by non-rationed area of Mauza Joar Sahara bearing jurisdiction list No. 271, Mouza Bowra bearing jurisdiction list No. 192 and Mauza Kanthaldia bearing jurisdiction list No. 295;

West : Covered by statutory rationed area of Gulshan Model Town comprising mouzas Kurail and Bholā bearing jurisdiction list Nos. 276 and 277, respectively, and the areas of Dacca Cantonment and Dacca International Airport; and

- (c) the following plots of Mauza Meradia bounded by the areas as mentioned below:—

Plot Nos. 573 to 877, 885, 886, 908 to 911, 916 to 925, 966 to 969, 983 to 991, 1149, 1160, 1163 and 1165 to 1169 under jurisdiction list No. 289 (old) 121 (new);

North: Covered by non-rationed area of Mauza Badda, Jurisdiction list No. 291.

South: Covered by Statutory Rationing Area of Mouza Goran, jurisdiction list No. 288.

East : Covered by non-rationed area Mouza Nandipura, jurisdiction list No. 317;

West : Covered by Statutory Rationing Area of Mouza Ullan, jurisdiction list No. 290 and Mouza Shahar Khilgaon, jurisdiction list No. 287;" and

(2) In paragraph 2, *after* sub-paragraph (7), the following new sub-paragraphs shall be *added*, namely:—

West : Covered by statutory rationed area of Gulshan Model Town comprising Mauzas Kurail and Bhola bearing jurisdiction list Nos. 276 and 277, respectively and the areas of Dacca Cantonment and Dacca International Airport ; and

(c) the following plots of Mauza Meradia bounded by the areas as mentioned below :—

Plot Nos. 573 to 877, 885, 886, 908 to 911, 916 to 925, 966 to 969, 983 to 991, 1149, 1160 1163 and 1165 to 1169 under jurisdiction list No. 289 (old) and 121 (new) ;

North : Covered by non-rationed area of Mauza Badda, J. L. 291,

South : Covered by Statutory Rationing Area of Mauza Goran, J. L. No. 288.

East : Covered by non-rationed area Mauza Nandipura, J. L. No. 317.

West : Covered by Statutory Rationing Area of Mouza Ullan, J. L. No. 290 and Mauza Shahar Khilgaon, J. L. No. 287 ;" and

(2) in paragraph 2, *after* sub-paragraph (7), the following new sub-paragraphs shall be *added*, namely :—

"(8) The part of Mauza Sitalakhya bearing jurisdiction list No. 181 covered by cadastral survey plot Nos. 1 to 480 within the police-station Narayanganj in the district of Dacca.

(9) The part of Mauza Masinabadh bearing jurisdiction list No. 179 covered by cadastral survey plot Nos. 1 to 62 within the police-station Narayanganj in the district of Dacca".
