NOTIFICATION

Dhaka, the 16th April, 1986

No. S.R.O. 124-L/86/SVI/LC-56/83.—In exercise of the powers conferred by sub-section (I) of Section 35 of Industrial Relations Ordinance, 1969 (XXIII of 1969), the Government is pleased to re-specify the jurisdiction of the 1st, 2nd and 3rd Labour Courts established under this Ministry's Notification S.R.O. 131-L/81/SVI/LC-52/81/120, dated the 24th April 1981, and direct that the following amendments shall be made in the aforesaid Notification, namely:—

- (a) in the Table for entries at serial 1, 2 and 3 in column 1 and the entries relating thereto in column 2 the following shall be substituted, namely:—
 - "1. 1st Labour Court, Dhaka .. (a) Tejgaon, Gulshan, Ramna and Motijheel police stations of Dhaka Metropolitan Area.
 - (b) Manikganj, Munshiganj, Narshingdi, Tangail and Jamalpur Zilas.
 - 2. 2nd Labour Court, Dhaka .. (a) Demra, Sutrapur, Kotwali police stations of Dhaka Metropolitar Area.

- (b) Faridpur, Rajbari, Gopalganj, Shariatpur and Madaripur Zilas,
- (c) The whole of Bangladesh in respect of cases falling within jurisdiction of more than one Labour Court except as provided in paragraph 2.
- 3. 3rd Labour Court, Dhaka .. (a) Lalbag, Mirpur, Mohammadpur and Dhanmondi police stations of Dhaka Metropolitan Area and other areas of Dhaka Metropolitan Area which are not included within the jurisdiction of 1st and 2nd Labour Courts.
 - (b) Netrokona, Gazipur, Kishoreganj, Sherpur, Narayanganj and Mymensingh Zilas.
 - (c) The whole of Bangladesh in respect of all cases arising out of Newspaper Employees Wage Board Award, 1977.";
- (b) for paragraph 2 and 3 the following shall be substituted, namely :-
 - "2. No Labour Court, except the 3rd Court, Dhaka shall have jurisdiction of the cases arising out of non-implementation of the Newspaper Employees Wage Board Award of 1977.
 - Notwithstanding anything contained in this notification all cases pending in 1st, 2nd and 3rd Labour Courts, Dhaka immediately before this Notification shall continue to be proceeded within the courts where they are pending."
