#### NOTIFICATION

#### Dacca, the 22nd April, 1976.

No. 21/3/76/Rules.—The President has been pleased to constitute the Rajshahi Division Development Board with immediate effect. The charter of the Board shall be as follows:

- Functions of the Board.—The following shall be the functions of the Board:
  - (a) Preparation of the schemes/projects for the development of the Division as a whole. The Board should maintain close liaison with the Planning Cells of various Ministries/Divisions in the matter of formulation of schemes/projects for the region.

- (b) Approval of schemes/projects costing up to Tk. 10 lakhs. Schemes beyond this limit shall be approved by the concerned Ministry/ Planning Commission.
- (c) Execution of the schemes/projects through the concerned agencies of the Government.
- (d) Supervision during execution of the schemes/projects by the concerned, agencies of the Government.
- (e) Allocation of funds from the revolving fund of the Board to the executing concerned agency. Such funds will be recovered from the agency concerned later from its ADP allocation.
- (f) Execution of any scheme/project of special nature pertaining to development of the Division, with the approval of the Government. Report on execution of such schemes/projects should be sent to the Planning Commission for record.
- (g) Any other function assigned to it by the Government from time to time.
- Composition of the Board.—The Board shall have a Chairman, a Vice-Chairman, a full-time Secretary and a full-time Member, besides some other part-time Members as detailed below:
  - (a) Commissioner, Rajshahi Division-Ex-Officio Chairman.
  - (b) Additional Commissioner, Rajshahi Division—Ex-Officio Vice-Chairman.
  - (c) Deputy Commissioner, Rajshahi, Pabna, Bogra, Rangpur and Dinajpur— Ex-Officio Members.
  - (d) An Officer of the rank of Additional Deputy Commissioner—Full-time

    Member-Secretary.
  - (e) An Officer of the rank of Superintending Engineer—Full-time Planning-Member.
  - (f) A Section Chief of the Planning Commission-Part-time Member.
  - (g) Deputy Director-General of Industries, Rajshahi Division—Part-time
    Member.

The Board shall meet as often as necessary but at least once a month. Besides regular meetings, the Board shall also meet in emergent meetings as and when decided by the Chairman.

The Board shall also have a Consultative Committee comprising of divisional level representative of various development agencies of the Government and one non-official representative from each Subdivision in the Division to be nominated by the Chairman. The Consultative Committee shall assist the Board in the formulation, preparation and implementation of the schemes/projects, and shall meet as and when decided by the Chairman.

3. Head Office of the Board and its staff .- The Head Office of the Board shall be located at Rajshahi Town, and the Board may open Regional Offices in District Headquarters or any other place within the Division with the approval of the Government. The Board shall have its own office building and until such building is constructed, the office shall be housed in any convenient accommodation at Rajshahi Town.

The Board shall appoint its own staff according to the recruitment rules, scales of pay, etc., approved by the Government.

- 4. Funds and Financial powers.—The Board shall have a non-lapsable revolving fund of Tk, 5 crores to be granted by the Government from the Development Budget and that the expenditure on account of staff, etc., for the Board will be borne on the Revenue Budget. The Chairman shall have power to authorise expenditure up to Tk. 5 lakhs and the Vice-Chairman up to Tk, 2 lakhs. The Board may allocate funds for execution of any development scheme/project to any Government/autonomous agency subject to the condition that the agency shall reimburse the amount from its ADP allocation in the following year.
- 5. Framing of rules for operation.—The Board shall frame as quickly as possible financial and administrative rules for its operation, with the approval of the Government.

#### NOTIFICATION

No. S. R. O. 138-L/76 .- In exercise of the powers conferred by subsection (1) of section 60 of the Income-tax Act, 1922 (XI of 1922), the Government is pleased to exempt foreign contractors and consultants working in Bangladesh under an agreement with Ashuganj Fertilizer and Chemical Company Ltd., such agreement providing for the payment by the Ashuganj Fertilizer and Chemical Company Ltd., the amount of tax payable by such foreign contractors and consultants in respect of income derived by them, from so much of the tax on their income received or deemed to be received by, or accruing or arising or deemed to accure or arise to, them in Bangladesh as exceeds the tax that would have been payable by them had the said Ashuganj Fertilizer and Chemical Company Ltd. not entered into the agreement to pay such tax on their behalf.
