### Terms of reference.

The terms of reference of the Metropolitan Advisory Committee on law and order will be as follows:—

- The Committee will review the overall law and order situation of the metropolitan area and suggest measures for improvement.
- 2. It will advise the Government on ways and means of enlisting people's support for crime control and creating a happy law and order situation.
- 3. It will advise the Government as to how the spirit of service to the community can be best imbibed by the law-enforcing agencies.
- 4. It will consider and recommend special measures to deal with particular types of crimes or crimes in particular areas, as the case may be.
- 5. It will bring to the notice of the Government difficulties and handicaps being faced by the law-enforcing agencies in carrying out their duties.
- 6. It will bring to the notice of Government any gross irregularities or excessess committed by law-enforcing agencies and suggest effective remedial measures.
- 7. It will advise the Government on appropriate publicity and education on crime control and law and order.
- 8. The Committee will perform such other functions as may be assigned to it by the Government from time to time.

The Committee will meet at least once every month.
