RESOLUTION

Dacca, the 24th May 1977.

No. S. R. O. 158-L/77/S-VI/2(32)/77.—Whereas it is expedient to amend the Government Resolution No. S-VI/2(32)/77/191, dated the 20th April 1977, relating to the setting up of the Industrial Workers' Wages and Productivity Commission for the purpose hereinafter appearing;

The Government have, therefore, resolved to amend the said Resolution as follows:—

In the aforesaid Resolution, in paragraph 2, in clause (5), after the word "Resolution" at the end, the words "or on such matters relating to wages or other benefits of the workers as the Government may refer to the Commission" shall be added.

Ordered that the Resolution be published in the Gazette of Bangladesh.
