No. S.R.O. 162-L/76.-In exercise of the powers conferred by sub-clause (v) of clause(b) of sub-section (4A) of section 15BB of the Income-tax Act, 1922 (XI of 1922), the National Board of Revenue is pleased to approve M/s. East Asiatic Trading Corporation Limited, Chittagong in respect of its cold storage unit at Reazuddin Road, Chittagong for the purpose of exemption from the tax under the said section for the period from the 1st day of April, 1969 to the 30th day of June, 1971, both days inclusive. This exemption is allowed in pursuance of S. R. O. 132 (R)/67, dated 1-7-1967 issued by the then Central Government and is subject to the conditions being fulfilled as are laid down in sub-clause (iva) of clause (b) of sub-section (4A) of section 15BB of the Income-tax Act.
