No. S.R.O. 162-L/82.—In exercise of the powers conferred by paragraph 16 of the Essential Commodities Control Order, 1981, the Government is pleased to fix the 31st December, 1982, to be the date beyond which the Scheduled articles specified below shall not be kept in the possession of any importer, producer or dealer:—

- (1) P.V.C. Compound (Shoe grade).
- (2) Electric Bulbs (15-100 watts. only).
- (3) Cellophane paper, all sorts except MST and MXXT type, which may be allowed to pharmaceutical industry as per their entitlement only.
- (4) Dry Cell Battery (Standard and medium sizes only).
- (5) Electric Ceiling Fans.
- (6) Pilfer proof cap except for pharmaceutical industries within their entitlement.
- (7) Empty lacquered Drums.
- (8) Metal and paper transfer of all foreign bicycle brands.

- (9) Steel Reeds of sizes up to 60s.
- (10) Electrical Accessories, *e.g.*, bed switches, table lamp switch, piano switch up to 15 Amp and 2 and 3 pin plugs only.
- (11) Hand sprayers, except those required by Tea Gardens requiring special automisation.
- (12) Locks and Padlocks up to 2½" size, except combination and special locks.
- (13) Torch light.
- (14) Telephone set and exchanges up to 10 lines.
- (15) Duplicating ink under cash/credit and barter.
