No. S. R. O. 163-L/81/LIWVI/6(5)/80.—In exercise of the powers conferred by sub-section (1) of section 3 of the Shops and Establishments Act, 1965 (E. P. Act VII of 1965), the Government is pleased to suspend the operation of sections 4, 8 and 11 of the aforesaid Act in respect of the Airports Development Agency Limited, Dacca, for a period of one year, subject to the following conditions, namely :—

- (a) the workers required to work overtime shall be paid wages at double the ordinary rates of wages for working beyond the normal working period of nine hours a day or forty-eight hours a week; and
- (b) the workers deprived of weekly holidays shall be allowed compensatory holidays within the period of operation of this Notification.
