ORDINANCE

further to amend the Bangladesh Nationalised and Private Organisations
(Regulation of Salary of Employees) Order, 1972.

Whereas it is expedient further to amend the Bangladesh Nationalised and Private Organisations (Regulation of Salary of Employees) Order, 1972 (P.O. No. 54 of 1972), for the purpose hereinafter appearing;

AND WHEREAS Parliament is not in session and the President is satisfied that circumstances exist which render immediate action necessary;

Now, THEREFORE, in exercise of the powers conferred by clause (1) of article 93 of the Constitution of the People's Republic of Bangladesh, the President is pleased to make and promulgate the following Ordinance:—

1. Short title and commencement.—(1) This Ordinance may be called the Bangladesh Nationalised and Private Organisations (Regulation of Salary of Employees) (Amendment) Ordinance, 1975.

- (2) It shall be deemed to have come into force on the 1st day of May, 1972.
- Substitution of Article 8, P.O. No. 54 of 1972.—In the Bangladesh Nationalised and Private Organisations (Regulation of Salary of Employees) Order, 1972 (P.O. No. 54 of 1972), for Article 8 the following shall be substituted, namely:—
- "8. Notwithstanding anything contained in any other law for the time being in force or in any contract or in any rules or regulations or in terms and conditions of service of an employee, the amount that shall not be paid to an employee under this Order shall be deposited into the Government Treasury under the Head 'XLVI-Misc-Misc-other items' and the savings certificates in which such amount has been invested shall be deemed to be cancelled and to cease to have any surrender value."

jurther to amend the Bangladesh Small and Cottage Industries Corporation Act, 1957

Whereas it is expedient further to amend the Bangladesh Small Cottage Industries Corporation Act, 1957 (E. P. Act XVII of 1957), for the purposes hereinafter appearing;

AND WHEREAS Parliament is not in session and the President is satisfied that circumstances exist which render immediate action necessary;

Now, THEREFORE, in exercise of the powers conferred by clause (1) of Article 93 of the Constitution of the People's Republic of Bangladesh, the President is pleased to make and promulgate the following Ordinance:—

 Short title and commencement.—(1) This Ordinance may be called the Bangladesh Small and Cottage Industries Corporation (Amendment) Ordinance, 1975.

- (2) It shall be deemed to have come into force on the 1st day of January, 1973.
- Amendment of long title and preamble, E. P. Act XVII of 1957.—The Bangladesh Small and Cottage Industries Corporation Act, 1957 (E. P. Act XVII of 1957), hereinafter referred to as the said Act, in the long title and preamble, the words "and cottage" shall be omitted.
- Amendment of section 1, E. P. Act XVII of 1957.—In the said Act, in section 1, in sub-section (1), the words "and Cottage" shall be omitted.
- 4. Amendment of section 2, E. P. Act XVII of 1957.—In the said Act, in section 2,—
 - (i) in clause (c) the words "and Cottage" shall be omitted;
 - (ii) clause (d) shall be omitted; and
 - (iii) for clause (g), the following shall be substituted, namely:-
 - "(g) 'small industry' means an industrial unit which is a factory as defined in clause (f) of section 2 of the Factories Act, 1965 (E. P. Act IV of 1965), and the total investment in fixed assets including value of land of which does not exceed such amount as the Government may, by notification in the official Gazette, fix and such notification may be given retrospective effect."
- 5. Amendment of section 3, E. P. Act XVII of 1957.—In the said Act, in section 3, the words "and Cottage" occurring twice shall be omitted in both places.
- 6. Amendment of section 22, E. P. Act XVII of 1957.—In the said Act, in section 22, for sub-section (1) the following shall be substituted, namely:
- "(1) The Corporation may, with the previous approval of the Government, issue and sell bonds and debentures carrying interest at such rate as may be approved by the Government for the purpose of raising its working capital:

Provided that the total of the sums due on such bonds and debentures issued and outstanding and of the contingent liabilities of the Corporation in respect of guarantees or underwriting agreements shall not at any time exceed Taka twenty five crore or such higher amount as the Government may, by notification in the official Gazette, fix.".

- 7. Amendment of section 24, E. P. Act XVII of 1957.—In the said Act, in section 24, the words "and cottage" wherever occurring shall be omitted in all places.
- 8. Amendment of section 28, E. P. Act XVII of 1957.—In the said Act, in section 28, for the words "rupees three" the words "Taka eighteen" shall be substituted.
- 9. Savings.—Anything done or any action taken under the said Act before the promulgation of this Ordinance shall be deemed to have been done or taken under that Act as amended by this Ordinance as if the amendments were in force at the time such thing was done or action taken.
