RESOLUTION

Dacca, the 8th June 1977.

**No. ED/P&S/Con-10/77-320.**—The Martial Law Inspection Committee's Report on the affairs of the Department of Printing and Stationery reveals serious irregularities, malpractices and fall of productive capacity in all its units. Accordingly Government have decided that a Committee be constituted immediately to thoroughly examine the overall position of the Department and submit their report within a month. The Committee shall consist of the following :—

- (1) Mr. N. A. Khan, Joint Secretary, Establishment Division—*Chairman.*
- (2) Mr. S. M. Israil Huq, Deputy Secretary, Establishment Division—*Member-Secretary.*
- (3) Mr S. K. Das, Deputy Secretary, Establishment Division, O & M Wing—*Member.*
- (4) One representative from the Ministry of Finance, of the rank of Deputy Secretary—*Member.*
- (5) One officer from the Department of Printing and Stationery to be nominated by the Controller of Printing and Stationery—*Member.*

**Terms of reference.**

- (1) Assessment of the capacity of the Printing Presses and optimum utilisation thereof.

- (2) To assess present condition of the machinery and equipment, existing facilities for repair, replacement and maintenance.
- (3) Possibilities of increasing productive capacities and measures to be taken for its modernisation.
- (4) Rationalisation and streamlining of management set up.
- (5) To scrutinise the suitability of candidates appointed or promoted since Liberation.

In the aforesaid Rules, in rule 2, in clause (ii),—

(1) *for* sub-clause (a) the following shall be *substituted*, namely:—

“(a) in the Commissioner's Divisions of Rajshahi and Dacca excluding Faridpur district—the Collector of Excise, Dacca”; and

(2) for sub-clause (c) the following shall be *substituted*, namely:—

“(c) in the Commissioner’s Division of Khulna and Faridpur district of Dacca Commissioner’s Division—the Collector of Excise, Khulna,”.
