Dacca, the 14th June, 1976.

No. S.R.O. 182-L/76/FC-10/Law-1(2)/76.—In exercise of the powers conferred by section 15 of the Irrigation (Imposition of Water Rate) Ordinance, 1963 (E. P. Ordinance VII of 1963), the Government is pleased to make the following amendment in the Irrigation (Imposition of Water Rate) Rules, 1966, namely:—

Amendments

In the aforesaid Rules,-

- (a) in rule 2,-
 - (i) in clause (b), for the words "an Irrigation Division" the words "the Bangladesh Water Development Board" shall be substituted;
 - (ii) for clause (c) the following shall be substituted, namely:-
 - "(c) 'Authority' means the Bangladesh Water Development Board constituted under the Bangladesh Water and Power Development Boards Order, 1972 (P.O. No. 59 of 1972);"; and
 - (iii) clauses (f) and (g) shall be omitted; and
- (b) in rule 10,-
 - (i) in sub-rule (1), the words and comma "in case of non-transferred projects and the beneficiaries, in case of transferred projects" shall be *omitted*; and
 - (ii) in sub-rule (2), the words and comma "In case of non-transferred projects," shall be omitted.
