No. S.R.O. 195-L/79.—In exercise of the powers conferred by the proviso to Article 133 of the Constitution of the People's Republic of Bangladesh, the President, after consultation with the Bangladesh Public Service Commission as required by clause (2) of Article 140 of that Constitution, is pleased to make the following amendments in the Senior Research Officer (Organisation and Management Division) Recruitment Rules, 1976, namely:—

In the aforesaid Rules—

- (a) in rule 1, in sub-rule (1), for the words "Organisation and Management Division" the words "Establishment Division" shall be substituted;
- (b) in rule 2, for clause (c) the following shall be substituted, namely:—  
"post" means the post of Senior Research Officer in the Establishment Division; and
- (c) in rule 3, in clause (a)—
  - (i) for the words "Organisation and Management Division" the words "Establishment Division" shall be substituted; and
  - (ii) for the figure "10" the figure "8" shall be substituted.

Dacca, the 30th June, 1979.

No. S.R.O. 196-L/79/S-X/1E-1/79/250.—In exercise of the powers conferred by section 52 of the Water Supply and Sewerage Authority Ordinance, 1963 (E.P. Ord. No. XIX of 1963), the Government is pleased to make the following further amendments in the Dacca Water Supply and Sewerage Authority (Sewer connection and levy of Sewer Rate) Rules, 1966, namely:—

In the aforesaid Rules,—

- (1) in rule-3, in sub-rule (1), for the words and full-stop "The Form may be had from the office of the Chief Engineer or from any other office of the Authority specified by him on payment of fifty paisa. A copy of these rules may also be had on payment of rupee one only." The words and full-stop "The Form may be had from the office of the Commercial Manager or from any other office of the Authority as may be authorised in this behalf by the Commercial Manager on payment of Taka one only. A copy of these rules may also be had on payment of Taka five only." shall be substituted;
- (2) after rule 5, the following new rule shall be inserted, namely:—

"5A. Cost of laying service line, etc.—(1) The service line shall be laid by the Authority from the WASA main to the last pit of the applicant. The cost of such laying as may be established and determined by the authority from time to time with the prior approval of the Government and in accordance with the standard schedule charges shall be borne by the applicant.

(2) The cost of laying the service line under sub-rule (1) shall be payable by the applicant in advance as soon as the application for a connection is granted. If full payment for cost of laying service line and other charges, if any, are not made within ten days of the receipt of permission, the Chairman may cancel such permission:

Provided that if the materials required for laying the service line are not available in the WASA store, the service line shall be laid by the Authority on receipt of supply of such materials and the labour charges from or on behalf of the applicant."

No. S.R.O. 197-L/79/S-X/1E-1/79/251.—In exercise of the powers conferred by section 52 of the Water Supply and Sewerage Authority Ordinance, 1963 (E.P. Ord. No. XIX of 1963), the Government is pleased to make the following further amendments in the Dacca/Chittagong Water Supply and Sewerage Authority (Water Connection and Levy of Water Rate) Rules, 1966, namely:—

In the aforesaid Rules,—

- (1) in rule 3, in sub-rule (2), for the words "rupee one for a copy of the Rules and fifty paisa for a copy of the Form" the words "Taka five for a copy of the Rules and Taka one for a copy of the Form" shall be substituted;

(2) in rule 8, for the words and comma "meter chamber shall be located within the holding in a suitable place, as approved by the Chief Engineer" the words "underground or overground reservoir in the holding and the meter shall be installed in a suitable place within the holding as approved by the officer authorised in this behalf by the Authority" shall be *substituted*; and

(3) in rule 9,—

(i) for the words and comma "within a month from the date of receipt of order granting the permission, the Chief Engineer may cancel such permission" the words and comma "within fifteen days from the date of receipt of order granting the permission, the Chairman may cancel such permission" shall be *substituted*; and

(ii) for the the full-stop at the end a colon shall *substituted* and thereafter the following proviso shall be *inserted*, namely:—

"Provided that if the materials other than meter required for laying the service line are not available in WASA Store, the service line shall be laid by the Authority on receipt of supply of such materials and labour charges from or on behalf of the applicant."
