ORDER

Dacca, the 27th June, 1977.

No. S.R.O. 201-L/77.—In exercise of the powers conferred by sub-section (1) of section 8 of the Jute Ordinance, 1962 (LXXIV of 1962), the Government is pleased to fix, for the period beginning on the 1st day of July, 1977 and ending the 30th June, 1978, the minimum price of Jute at Taka ninety per maund at growers' level all over Bangladesh below which loose jute of the lowest grade, that is, X-Bottom grade shall not be sold or purchased.

Explanation-The specification of the X-Bottom grade shall be as follows:

- (i) any strength and any colour;
- (ii) occasional croppy and gummy tops with cuttings and specks and hard centred jute, the maximum proportion of cuttings being not in excess of 40 per cent, of the weight;
- (iii) generally corresponding to Bangla White 'D' when converted to pucca.
