#### NOTIFICATION

Dacca, the 16th July, 1977.

No. S.R.O. 222-L/77.—In exercise of the powers conferred by the proviso to article 133 of the Constitution of the People's Republic of Bangladesh, the President, after consultation with the Public Service (Second) Commission as required by clause (2) of article 140 of that Constitution, is pleased to make the following rules, namely:—

THE NON-GAZETTED EMPLOYEES (DEVELOPMENT PROJECTS UNDER GEOLOGICAL SURVEY OF BANGLADESH) RECRUITMENT RULES, 1977.

- 1. Short title.—These rules may be called the Non-gazetted Employees (Development Projects under Geological Survey of Bangladesh) Recruitment Rules, 1977.
  - 2. Definition.- In these rules, unless the context otherwise requires-
    - (a) "appointing authority" means in relation to any specified post or class of such posts, any officer authorised by the Government to make appointment to such post or class of posts:
    - (b) "commission" means the Public Service (Second) Commission;

- (c) "recognized university" means a university established by or under any law for the time being in force and includes any other university declared by the Government, after consultation with the Commission, to be a recognized university for the purposes of these rules;
- (d) "requisite qualification" in relation to a specified post, means the qualification prescribed in the schedule in relation to that post;
- (e) "schedule" means the schedule annexed to these rules;
- (f) "specified post" means a post specified in the schedule.
- 3. Procedure of recruitment.—(1) Subject to the provisions of the Schedule and such instructions as may be issued from time to time, relating to reservation for the purpose of clause (3) of article 29 of the Constitution, appointment to a specified post shall ordinarily be made by direct recruitment.
- (2) No person shall be appointed to a specified post unless he has the requisite qualification, and in the case of direct recruitment, also he is within the age limit, if any, prescribed in the schedule for that post.
- 4. Appointment by promotion.—A person shall not be eligible for appointment by promotion to a post if he has not been confirmed in any post on the ground of unsatisfactory service records or of his failure to fulfil any other requirement for confirmation to that post.
- 5. Appointment by direct recruitment.—(1) No appointment to a specified post by direct recruitment shall be made except upon the recommendation of the commission.
  - (2) No person shall be eligible for appointment to a specified post if he-
    - (a) is not a citizen of Bangladesh;
    - (b) is married to, or has entered into a promise of marriage with, a person who is not a citizen of Bangladesh.
- (3) No appointment to a specified post by direct recruitment shall be made until—
  - (a) the person selected for appointment is certified by a Medical Board set up for the purpose by the Government to be medically fit for such appointment and that he does not suffer from any such organic defect as is likely to interfere with the discharge of the duties of the post;
  - (b) the antecedents of the person so selected have been verified through appropriate agencies and found to be such as do not render him unfit for appointment to Government service.
- (4) No person shall be recommended for appointment to a specified post unless—
  - (a) he applied in such form, accompanied by such fee and before such date, as was notified while inviting applications for the post; and
  - (b) in the case of a person already in Government service or in the service of a local authority or a corporation, he has applied through his official superior.
