এস, আর, ও নং ২২৪-আইন/৯৬—Army Act, 1952 (XXXIX of 1952) এর section 176A ত প্রদত্ত ক্ষমতাবলে সরকার pay and Allowance Regulations for the Bangladesh Army, Volume-1 এর নিম্নরূপ সংশোধন করিল, যথাঃ—

উপরি-উক্ত Regulations এর—(১) rule 34, 35, 36 এবং 37 এর পরিবর্তে নিম্নরূপ rule 34, 35, 36 এবং 37 প্রতিস্থাপিত হইবে, যথাঃ—

“34. Officers who have successfully completed basic/refresher parachute/commando training and are employed on parachute/commando duties will receive parachute/commando pay at such rate as may be fixed from time to time with effect from the date of commencement of training, subject to the conditions specified in rules 35 to 37.

35. Except as laid down in rule 37, parachute/commando pay will remain in issue until an officer vacates his operational parachute/commando appointment. An officer who is permanently posted away from a parachute/commando unit/formation will cease to draw parachute/commando pay with effect from the date on which he is struck off the strength of a parachute/commando unit/formation.

36. The general conditions regarding the commencement and the cessation of additional pay as laid down in rules 107 and 108 will govern the commencement and the cessation of parachute/commando pay, subject to the following modifications :

- (i) In ordinary cases of sickness or injuries parachute/commando pay will continue for 28 days.
- (ii) Administrative personnel will not be eligible for parachute/commando pay unless they are required to qualify as parachutists commandos and remain liable for parachute/commando duty.
- (iii) Parachute/commando pay will not be admissible for any day during which pay is for feted.

37. Parachute/commando pay will be continued during absence on account of injuries due to parachute/commando duties or on account of wounds received in action against the enemy, for a period not exceeding 91 days. It will, however, cease forthwith if within the period of 91 days, the individual concerned joins for duty in an appointment or with a unit for which parachute/commando pay is not admissible.”;

(২) rule 237 এর পরিবর্তে নিম্নরূপ rule 237 প্রতিস্থাপিত হইবে, যথা:—

“237. J.C.O's W.Os and other ranks who have successfully completed basic/refresher parachute/commando training and are employed on parachute/commando duties will receive parachute/commando pay with effect from the date of commencement of training under the conditions applicable to officers as laid down in rules 35 to 37, with the exception that in the case of other ranks parachute/commando pay will continue for 21 days in ordinary cases of sickness or injuries.”
