PROCLAMATION

Special Tribunal Case No. 13/1976.

Whereas it has been made to appear that (1) Dhanu Mia, son of Lal Mia of Jhagrarchar, P.S. Bhairab, Dist. Mymensingh, is required for the purpose of trial in the Special Tribunal No. 13, Dacca, u/o XL/77 in the abovenoted Special Tribunal Case;

And whereas this Court has reason to believe that the said accused person is absconding or concealing himself to avoid appearance or arrest for the said purpose;

Now, therefore, in exercise of powers conferred by Ordinance XL/77, this Special Tribunal No. 13, Dacca, do hereby direct—

This said Mr Dhanu Mia, son of Lal Mia, to appear in this Court at Dacca on 28th August 1978 in Special Tribunal Case No. 13/76, failing which he will be tried *in absentia* and his properties may be forfeited to the Government.
