(Customs and Sales Tax)

ORDER

Dhaka, the 7th June, 1984

No. S.R.O. 230-L/84/842/Cus.—In exercise of the powers conferred by clause (c) of section 21 of the Customs Act, 1969 (IV of 1969), and section 5 of the Sales Tax Ordinance, 1982 (XVIII of 1982), and in supersession of its Orders No. S.R.O. 146-L/83/775/Cus., dated the 25th April, 1983 and No. S.R.O. 155-L/83/15/ST., dated the 11th May, 1983, the National Board of Revenue is pleased to authorise the repayment of the customs-duties and sales tax at the rate of Taka 412.00 per ton paid on the importation of pulp by the Bangladesh Chemical Industries Corporation which has been used in the manufacture of newsprint by the Newsprint Factory, Khulna, subject to the following conditions, namely:—

- (a) the said rate of repayment is inclusive of customs-duty and sales tax paid on the importation of pulp either through Chittagong or Chalna Port;
- (b) the newsprint is sold in the local market;
- (c) the quantum of sale shall be determined through invoices submitted by the Newsprint Factory, Khulna; and
- (d) the repayment shall be made from Chalna Customs House, Khulna, only.

2. This order shall be deemed to have taken effect on and from 4th October 1982.
