

THE BANGLADESH COLLEGE OF PHYSICIANS AND SURGEONS (AMENDMENT) ORDINANCE, 1976

Ordinance No. LX of 1976

AN ORDINANCE

further to amend the Bangladesh College of Physicians and Surgeons Order, 1972.

Whereas it is expedient further to amend the Bangladesh College of Physicians and Surgeons Order, 1972 (P.O. No. 63 of 1972), for the purpose hereinafter appearing;

Now, THEREFORE, in pursuance of the Proclamations of the 20th August, 1975, and the 8th November, 1975, and in exercise of all powers enabling him in that behalf, the President is pleased to make and promulgate the following Ordinance:—

- Short title and commencement.—(1) This Ordinance may be called the Bangladesh College of Physicians and Surgeons (Amendment) Ordinance, 1976.
- (2) It shall be deemed to have come into force on the 8th day of June, 1972.

2. Amendment of Article 6, P.O. No. 63 of 1972.—In the Bangladesh College of Physicians and Surgeons Order, 1972 (P.O. No. 63 of 1972), in Article 6, in clause (2), for the proviso the following shall be substituted, namely:-

"Provided that in the first election for the constitution of the Council one-half of the members of the Council shall be elected for a term of only two years.".
