PROCLAMATION

Whereas it has been made to appear to me that accused Mofakhar, son of Md. Abdul Jalil, ex-Cashier, in-charge of Uttara Bank, Pabna, Vill. and P.S. Rajbari, Dist. Faridpur, at present C/o. Kazi Mozaharul Karim, No. 39, Nowabganj Road (Near Peelkhana), P. S. Lalbagh, Dist. Dacca, is required for the purpose of the trial u/s. 419/409/467/109, B.P.C., in the Court of the Sessions Judge, Pabna;

And whereas this Court has reason to believe that the said accused person is absconding or concealing himself to avoid appearance or arrest for the said purpose ;

Now, therefore, in exercise of the powers conferred by section 6(IA) of Act XL of 1958, as amended, *vide* Ordinance No. VI of 1978, the Court do hereby direct that the above accused person to appear in the Court by 13th September, 1979 at 10-30 a.m., failing which he will be tried *in absentia*.
