No. 385/SML.—Whereas it appears that the undernamed accused persons are absconding or concealing themselves to avoid appearance or arrest for their trial in the Court of the undersigned.

Now, therefore, in exercise of the powers conferred upon me under clause 7 of section 3 of the Martial Law Regulation No. I of 1975, the accuseds named below are ordered to appear before the Summary Martial Law Court, Rangpur in the M.L.R. Cases as noted against their names within 7 days from the date of publication of this Notification failing which they will be tried *in absentia* and in that case their properties may be forfeited to the State:
