No. S.R.O. 238-L/LIWVI/11(16)/78/79.—In exercise of the powers conferred by section 5 of the Factories Act, 1965 (E.P. Act IV of 1965), the Government is pleased to exempt M/S. Chatak Cement Co. Limited, Sylhet, from the provisions of sections 50, 51, 53, 54 and 55 of the said Act for a period of six months.

PUBLIC NOTICE No. 42(79)/IMPORT

Dacca, the 8th August, 1979.

It is hereby notified for the information of all concerned that it has been decided by the Government to abolish the system of direct import under Wage Earners Scheme as detailed in sub-para (2) of para 22 of the Import Policy Order, 1979-80. However, goods which will be shipped up to 15th September 1979 under Wage Earner Scheme will be exempted from this restriction. As

such, the sub-para (2) of para 22 of the Import Policy Order, 1979-80 shall be *deleted* with effect from 16th September 1979 and the existing sub-para (3) to (5) shall be *re-numbered* as para (2 to 4).

2. The restriction on direct import under Wage Earners Scheme as mentioned in the above paragraph shall not apply to the following cases:—

- (i) A Bangladeshi national living and earning abroad may import transports, machineries and equipments as permissible under Wage Earners Scheme direct provided they produce earning certificate from Bangladesh High Commission/Embassy, concerned along with other required documents. In such case they will be required to submit the original copy of earning certificate from Bangladesh High Commission/Embassy.
- (ii) The restriction on direct import will not apply to passenger's Baggage Rules and facility for import of goods permissible under Wage Earners Scheme and allowed under para 7(2) of Schedule I of ITC Schedule published under cover of SRO-134-L/79, dated 18th May 1979 to Bangladeshi nationals returning from abroad as accompanied and/or un-accompanied baggage.

3. The following printing mistake in the Import Policy Order, 1979-80 is corrected and notified for the information of all concerned:

In the 12th line of sub-para (2) of para 27, the words "of their local area except the importers" shall be *inserted* in between the words "importers" and "of the".
