- (a) a public limited company may raise capital up to twenty lac taka without the consent of the Government; and
- (b) a private limited company may raise capital up to fifty lac taka without the consent of the Government.

## PROCLAMATIONS

## Martial Law Case No. 187/84

Whereas it has been made to appear to me that the accused Md. Johur Ali, son of Hazi Mohiruddin of Tarapur Thutapara, P.S. Shibganj, Dist. Rajshahi, is required for the purpose of trial in Summary Martial Law Court No. 9, Rajshahi;

And whereas the Court has reason to believe that the said accused Md. Jahur Ali in the case abovementioned, is absconding or concaling himself to avoid appearance or arrest for the said purpose;

Now, therefore, in exercise of the powers conferred by Regulation 2(11) of the Martial Law Regulation No. I of 1982, this Summary Martial Law Court No. 9 at Rajshahi Circuit House, Rajshahi, do hereby direct the aforesaid accused person to appear in this court at 9.00 a.m. on 27th July 1984 in Shibganj P.S. Case No. 18, dated 31st July 1983, failing which he will be tried in absentia and his properties, both movable and immovable, may be forfeited to the Government.

## Martial Law Case No. 188/84

Whereas it has been made to appear to me that the accused Erfan Ali, son of Moslimuddin of Jaminpur, P.S. Shibganj, Dist. Rajshahi, is required for the purpose of trial in Summary Martial Law Court No. 9, Rajshahi;

And whereas the Court has reason to believe that the said accused Erfan All in the Case abovementioned, is absconding or concealing himself to avoid appearance or arrest for the said purpose;

Now, therefore, in exercise of the powers conferred by Regulation 2(11) of the Martial Law Regulation No. I of 1982, this Summary Martial Law Court No. 9 at Rajshahi Circuit House, Rajshahi, do hereby direct the aforesaid accused person to appear in this Court at 9.00 a.m. on 28th July 1984 in Shibganj P.S. Case No. 25, dated 28th April 1983, failing which he will be tried in absentia and his properties, both movable and immovable, may be forfeited to the Government.
