In the aforesaid Notification, in the Schedule, in Part I, *after* item (d) and the entries relating thereto in columns I and II, the following new item shall be *added*, namely:—

“(e) Bangladesh made spirit used for scientific and industrial purposes. Taka 150.00 per L.P.G.”
