In the aforesaid Order, in paragraph 10, in sub-paragraph (1), after the word "credit" at the end, the commas, words and figures ", provided that in case of filter tipped cigarettes imported under Wage Earner Scheme, shipment of the goods for which letters of credit were opened on or before 30th June, 1980, shall have to be completed by the 30th September, 1980" shall be *added* and shall be deemed always to have been so *added*.
