Dacca, the 10th July 1982.

No. S.R.O. 269-L/82/Misc-3/81 (Poll-IV)/411.—In exercise of the powers conferred by sub-section (1) of section 9 of the Manoeuvres, Field Firing and Artillery Practice Act, 1938 (V of 1938), the Government is pleased to define the area described in the Schedule below to be the area within which the carrying out of field firing and artillery practice may be authorised:

a. **Limit of the gun area.**—The gun position can be selected anywhere in the sea coast provided that:

(1) It is within 1500 yards from the high tide water level towards the east.
